THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI INDIRA GANDHI): (a) and (b) No exclusive documentary film on the heroic deeds of Company Quarter Master Havildar Abdul Hamid has been produced by Government. However, his brave performance is part of an item entitled "Tales of Valour" included in the Indian News Review No. 886, which was released to the cinemas all over the country on the 1st October, 1965. In addition, some shots of this story have been used in the film titled "Hamare Jawan", produced by the Government of Uttar Pradesh, and released through the Films Division on the 22nd October, 1965. Both the newsreel and the documentary film mentioned above are in circulation in

cinema houses. Copies are prepared in English and twelve Indian regional languages for distribution to cinema houses. In addition, copies in 16 mm version are also supplied to State Governments and the Field Publicity Organisation of the Central Government for non-commercial screenings, largely in rural areas.

It is understood that a film entitled "Havildar Abdul Hamid" is being produced by a private producer.
