- (a) whether Government have any action plan for the development of pulses, vegetables, fruits, cereals and sugarcane, etc. in Maharashtra State;
  - (b) if so, the details thereof;
- (c) the funds released for the State for this purpose for the last three years, item-wise; and
- (d) whether the funds released for the purpose were fully utilized, if not, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF AGRICULTURE (SHRI S.B.P.B.K. SATYANARAYANA RAO): (a) to (c) The deails of central sector/centrally sponsored schemes being implemented in Maharashtra for development of major crops and funds released thereunder during the last three years are given in the Statement (See below).

(d) Sometimes proposals are received from the State Government at the fag end of the financial year. Further, delays sometimes occur in release of funds to the implementing agencies. This results in a portion of the allocated funds remaining unutilised at the end of the year.
