## SUPPLY OF STEEL BARS TO EAST PAKISTAN BY INDIAN BUSINESS\*'\T

- (a) whether he received any telegram from Shri Nath Pai, a Member of the Lok Sabha, alleging that a Calcutta businessman has entered into a contract with Pakistani buyers to supply steel bars to East Pakistan;
- (b) if so, what action Government is taking on the complaint?

THE MINISTER OF STEEL AND MINES (SHRI N. SANJIVA REDDY): (a) A telegram was received in May by the Minister of Home Affairs from Shri Nath Pai urging a ban on export of steel to Pakistan, a copy of which was sent to the Ministry of Steel for taking

(b) The question was considered cerefully, and banning was not considered necessary at the time in view of the fact that these were common categories of steel which could be obtained by Pakistan quite easily from any other country, and the export earned valuable foreign exchange for India.
