NON-PAYMENT OF LOANS BY THE JAMMU AND KASHMIR GOVERNMENT

- \*543. SHRI D. THENGARI: Will the Minister of Home Affairs be pleased to state:
- (a) whether it is a fact that Jammu and Kashmir State Government has expressed its inability to repay loans totalling Rs. 75.21 crores drawn from the Central Government or even to pay the interest on this loan which totals Rs. 3 crores approximately; and
- (b) if so what steps Government propose to take in this regard?

THE MINISTER OF HOME AF-FAIRS (SHRI GULZARI LAL NANDA): (a) and (b) At the end of financial year 1963-64, the following amounts were due for repayment from the Government of Jammu and Kashmir on account of loans sanctioned: --

> Rs. 17,46,12,000 on account of principal, and Rs. 3,47,71,181 on account of interest.

As the State Government were unable to pay the amount in cash, a fresh loan of Rs. 17,46,12,000 was issued to the State Government on 4th December, 1964. The question of repayment of the amounts due on account of principal and interest has been taken up with the State Government.
