the first part of the question is concerned, the losses are borne by the Government.

SHRI D. THENGARI: May I know, Sir, what effort has been made by the Government to bring the internal prices at par with the international prices?

SHRI D. R. CHAVAN: Sir, various steps are being taken for the sugarcane development and also for intensification of sugarcane development.

Unless the quality of cane and peracre yield improves, there is no possibility to bring down the prices. All steps are being taken to reduce the cost of production, particularly so far as sugarcane is concerned.

SHRI A. D. MANI: The Minister mentioned that the earnings were about Rs. 9 crores. May I ask him to give us a break up of earnings, dollar as well as sterling?

Shri D. R. CHAVAN: The earnings from the U. K. would be about Rs. 1.58 crores for negotiated price quota of 25,479 tonnes and Rs. 1.51 crores for overall agreement quota of 50,237 tonnes. From Canada it is Rs. 1.43 crores for O.A.Q. of 52,762 tonnes. Our dollar earnings from the U.S.A. would be about Rs. 5.03 crores for 87,481 tonnes.

A proposal for setting up a Road Planning Board at the Centre is also under the active consideration of the Government of India.

INCREASE IN D.M.S. GHEE PRICE

*574. SHRIMATI LALITHA (RAJA-GOPALAN):‡ SHRIMATI TARA RAMA-CHANDRA SATHE:

Will the Minister of FOOD AND AGRICULTURE be pleased to state the reason for the rise in the price of ghee of the Delhi Milk Scheme from Rs. 9 to Rs. 11 a kilo?

THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI SHAH NAWAZ KHAN): Due to increase in the procurement price of raw milk, the cost of produc-

tion of ghee in the Delhi Milk Scheme has gone up. That is why it became necessary to the price of ghee from Rs. 9.30 to Rs. 11.00 per kilo with effect from 11-3-1965.

SHRIMATI LALITHA (RAJAGOPA-LAN): May I know, Sir, the reason why the price of ghee was suddenly raised from Rs. 9 to Rs. 11 per kilo in August when there was no scarcity of milk?

Shri SHAH NAWAZ KHAN: Although the availability of milk was somewhat easy in August, nevertheless the prices have increased very considerably for procurement of milk.

SHRIMATI TARA RAMCHANDRA SATHE: May I know, Sir, whether it is proper for the Government to increase the prices of all essential goods in order to maintain the price line?

SHRI SHAH NAWAZ KHAN: That is very desirable. But the question is if you want to get milk, you have got to pay for it.

SHRI FARIDUL HAQ ANSARI: May I know, Sir, whether the hon. Minister is aware that even the Delhi Milk Scheme ghee is adulterated?

SHRI SHAH NAWAZ KHAN: No, Sir. I emphatically deny this charge.

श्री विमलकुमार मन्नालालजी चौरिड़ियाः क्या श्रीमान् यह बतलाएंगे कि यह जो घी बनाया जाता है वह शुद्ध दूध में से मक्खन निकाल कर बनाते हैं इसकी वजह से स्वच्छ छाछ से जो घी बन कर ग्राता है उसके मुकाबले में वह ग्रच्छा नहीं होता, तो क्या उसकी क्वा-लिटी को सुधारने के लिये छाछ से घी निकालने का प्रयत्न किया जायेगा ?

श्री शाहनवाज खां: श्रक्सर यह जो घी सम्लाई किया जाता है यह उस दूध से बनता है जो कि लाने में खट्टा या दही सा बन जाता तकरीबन वही प्रोसेस हो जाती है जो छाछ से घा नकालने वाली बात है।

SHRI DEOKINANDAN NARAYAN At present the demand of milk is not being satisfied. Why is then milk used for producing ghee?

श्री शाहनवाज खां : मैंने ग्रर्ज किया कि जब दूध बहुत दूर से लाया जाता है तो कभी कभी वह दूध खट्टा हो जाता है ग्रीर जब दूध में खटास ग्रा जाती है तो उसे घी बनाने के काम में लाया जाता है।

SHRIMATI TARA RAMCHANDRA SATHE: May I know, Sir, if it is not the policy of the Government not to increase the prices of essential commodities and set an example to the traders in the country?

MR. CHAIRMAN: I think you made this suggestion before also.

SHRIMATI TARA RAMCHANDRA SATHE: They should set an example.

Mr. CHAIRMAN: We hope they would set an example.

SHRI SHAH NAWAZ KHAN: I might tell the hon. Member that in running the Delhi Milk Scheme the Government has suffered already almost to the extent of about Rs. one crore this year.

MR. CHAIRMAN: Too much of a good example.

Shri B. K. P. SINHA: Sir, since ghee as much as milk is an essential element of diet of the Indian people, may I know, if the Government are in a position to assure us that because of the efforts of some people the supply of ghee shall not be cut down as has been done in some States where to keep up the supply of milk the supply of some very delicious sweets has been cut down which has been causing great trouble to many people?

(No reply.)

SHRI ARJUN ARORA: May I know, Sir, if this is the second or the third increase in the rate of ghee during the last fifteen months?

SHRI SHAH NAWAZ KHAN: Sir, it is all very intimately connected with the procurement price of milk.

SHRI ARJUN ARORA: It is not a reply to my question. I want to know whether he has increased the rate a second time or a third time? How many times during the last 15 months has it been increased?

SHRI SHAH NAWAZ KHAN: I think it is the second time that we have increased it.

श्री सभापति : यह तो क्रुपा करने का मौका नहीं है, सवाल का मौका है ।

SHRI R. P. N. SINHA: Is it not a fact that the milk from which ghee is made is not a vegetarian substance?

Mr. CHAIRMAN: We are getting into metaphysics.

(a) The preliminary report of the Feasibility Survey in respect of hotel projects which is being undertaken with a view to determining the economics thereof was considered by the Board of Directors of India Tourism Hotel Corporation at its first meeting he'd on 9th August, 1965. In the light of this report, it is considered there is immediate need for setting up hotels in the first phase (to be completed by 1967-68) at the following places: Bombay, Calcutta Madras, Hyde abad. Varanasi, Aurangbad, Bangalore, Konarak, Agra and Jaipur.

Details with regard to each hotel project at these places are being worked out. In addition to building hotels, financial details are being worked out
