[THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI SHAH NAWAZ KHAN): (a) and (b) A draft request was forwarded to the U.N. Special Fund in July, 1964 for assistance towards the establishment of a National Soil Service Organisation in India. This organisation was proposed to be developed through action programme in the problem areas by starting a number of projects. The first one in order of priority was the Project for "soil survey and soil and water management in the Rajasthan Canal Area". The Plan of Operation received from the U.N. Special Fund relates only to the Project mentioned above. There is no mention of the proposal for a National Soil Service Organisation. The Government have, however, dropped the idea of creating a National Soil Service Organisation; but steps are being taken to strengthen the Soil Survey Organisation both at the Centre and in the States].
