(4) विभिन्न राज्यों में अधिप्राप्ति का तरीका सम्बन्धित राज्य सरकारों द्वारा निश्चित किया जाएगा, यद्यपि विभिन्न राज्यों में अधिप्राप्ति के तरीके में यथा-सम्भव एकरूपता लाने के लिये कोशिश की जाएगी।

इस नीति के अनुसार उपयुक्त कदम उठाये जा रहे हैं।

t[THE DEPUTY MINISTER IN THE MINISTRY OF FOOD AND AGRICULTURE (SHRI D. R. CHAVAN): (a) The outline of the food policy for 1965-66 is as follows: —

- (1) The existing zonal restrictions on the movement of rice, wheat, coarse grains and gram will continue.
- (2) Statutory rationing will be introduced in cities with a population of one million and above and in certain areas having a heavy concentration of industrial workers.
- (3) The surpluses and deficits of the different States with re-

gard to rice, wheat, coarse grains and gram will be assessed by the Planning Commission assisted by the Agricultural Prices Commission and a national budget will be drawn up. Each of the surplus States will have to deliver to the Central pool such quantities as may be determined by the Planning Commission and the supply to the deficit States will be made from out of the surpluses so procured and from the imports according to the national budget drawn up by the Planning Commission.

- (4) The method of procurement in the different States will be decided by the State Governments concerned though an attempt will be made to achieve as far as possible uniformity in the method of procurement in the different States.

Suitable steps are being taken in accordance with this policy.

#### SALE OF RICE IN BLACK MARKET IN DELHI

(SHRI D. R. CHAVAN): (a) Some complaints of rice having been sold in Delhi at prices higher than the controlled prices came to the Government's notice.

(b) Strict vigilance was exercised by the Delhi Administration to detect such practices and in the specific cases which came to their notice, action has been taken against the dealers involved. Steps have also been taken to increase the availability of rice in the Delhi markets. Arrangements have been made to import immediately 1700 tonnes rice from U.P. and Punjab and to have it distributed through cooperatives.
