• (b) and (c) The allegations were contained in a Memorandum a copy of which was received in the Department of Industry from the Central Bureau of Investigation on 7th August, 1965. One of the persons who *is* alleged to have signed the memorandum has denied any knowledge of it. Even so, the Chairman of the company is being requested to look into the allegations.

## ALLOY STEELS PLANT

•642. SHRI ARJUN ARORA: Will the Minister of STEEL AND MINES be pleased to state:

(a) whether the schedule for the completion of the Alloy Steels Plant at Durgapur has been revised; and

(b) if so, the reasons therefor?

THE MINISTER OF STEEL AND MINES (SHRI N. SANJTVA REDDY): (a) Yes, Sir.

(b) The main causes necessitating revision were delay in supply of certain technical data by the consortium of equipment suppliers from Japan and furnace suppliers from Canada and also certain delays in the receipt of drawings. There were also delays
