

MANUFACTURE OF CEMENT

717. SHRI M. M. DHARIA: Will the Minister of INDUSTRY AND SUPPLY be pleased to state what was the target of production of cement by the end of the Third Five Year Plan and how much has been realised so far?

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRY AND SUPPLY (SHRI BIBUDHENDRA MISRA): The target of production of cement by the end of the Third Five Year Plan is 13'2 million tonnes per annum. Production is now of the order of 10-75 million tonnes.

INADEQUATE RAILWAY SERVICE IN INDUSTRIAL AREAS OF POONA

(c) The demand for additional services in the industrial area served by the Pona-Lonavala section of the Central Railway having¹ been gone into in detail it was found that the services available at present cater by and large satisfactorily to the existing level and pattern of traffic offering there and as such there is no immediate traffic justification for the introduction of additional trains on the . section. Spare line capacity on the | section and terminal facilities at Poona for handling additional services are also not available at present.

(c) if so, what is the remedy offered to the affected persons?
