**RE CALLING ATTENTION NOTICE  
ABOUT A LETTER ALLEGEDLY  
CONNECTED WITH CERTAIN DIS-  
TURBANCES IN ORISSA**

SHRI LOKANATH MISRA (Orissa): I have given notice of a Calling Attention Motion which is a very serious matter. I am in possession of a letter which would lead the House to believe that it is really very serious. This letter was forwarded to the Union Home Minister on the 10th March by the Leader of the Opposition.

MR. CHAIRMAN: Leader of the Opposition where?

SHRI LOKANATH MISRA: Orissa. Till to-day the Union Home Minister has irresponsibly acted in not replying even though the writer categorically stated that he expected a reply. The letter reads like this and it is written to one in-law of the present Home Minister of Orissa. It is addressed to Hrishikesh Roy, Rourkela. The letter reads as follows:

"I came to Burdwan on 8-3-64. The situation in Pakistan is worst and the Calcutta Government is only to send the coming refugees to Dandakaranya. The other items will be carried by the Central Government and other Provincial Governments. So *golmal* will be happened at Tata, Rourkela, Jhatsaguda and Sambalpur. During the coming period give information to the police and betray Mr. Hari Pradhan. Secondly your enemies whoever maybe. Thirdly entrap Kapoor Mia in a wise method. Dictate everything to Gurucharan. If Hari Pradhan went to jail he will be always free from worries. Pradhan is always in upperhand by having influence with Muslims and Hindus. So you must also speak with him very nicely and closely and in tact betray him. Keep always with you about 100 persons to make all kinds of disturbances. During the riot nothing will be done by the Police. I will send you some round things to you within a day or two by my persons. If Kapoor wants to have your friendship, you must get good money and the cinema hall. You must pre-arrange your plan with your father-in-law."

SHRI BHUPESH GUPTA (West Bengal): So many in-laws.

SHRI LOKANATH MISRA: Uncle-in-law is the Home Minister of Orissa. He has no father-in-law. He is dead, I am told, and so he calls him father-in-law.
