

JOBS FOR LEPROSY PATIENTS IN PUBLIC UNDERTAKINGS

•196. SHRI A. D. MANI: Will the Minister of HEALTH be pleased to state:

(a) whether the Gandhi Memorial Leprosy Foundation has communicated to Government its finding that at least 28 categories of jobs, with an employment potential of over 8000, can be made available in public sector undertakings for leprosy patients;

(b) if so, whether public undertakings have been asked to give their reactions to these findings; and

(c) what are the reactions of public sector undertakings generally to this proposal?

THE MINISTER OF HEALTH (DR. SUSHILA NAYAR): (a) The Gandhi Memorial Leprosy Foundation has taken up a project to study and find out suitable jobs for non-infectious and arrested cases of leprosy in the existing industrial undertakings. They have not, however, communicated to Government their findings in the matter so far.

(b) and (c) Do not arise.

FOREIGN EXCHANGE FOR INDUSTRIES IN MAHARASHTRA

•197. SHRI BANSI LAL: Will the Minister of FINANCE be pleased to state:

(a) whether it is a fact that the Government of Maharashtra has asked the Central Government for allocation of foreign exchange for getting up sugar factories and certain other industries in the public sector in Maharashtra; and

(b) if so, the amount of foreign exchange asked by the Maharashtra Government and the amount sanctioned by the Central Government?

THE MINISTER OF PLANNING (SHRI B. R. BHAGAT): (a) and (b)

The Government of India have received no request from the Government of Maharashtra for allocation of foreign exchange for setting up of sugar factories or other industries in the public sector in that State.

RAO): (a) and (b) Government of Orissa have now proposed Manibhadra barrage project for which a preliminary report was sent to the Central Water and Power Commission. The Central Water and Power Commission have called for a detailed project report and estimate after conducting necessary investigations and studies.

NON-PROJECT LOAN FROM THE WORLD BANK

THE MINISTER OF PLANNING (SHRI B. R. BHAGAT): (a) Negotiations with international Development Association, an affiliate of the World Bank, for a credit of \$100.00 million were completed and the credit agreement was signed on August 11, 1965.

(b) About \$94.00 million out of the loan amount will be used for financing imported components, materials, balancing equipment and the spare parts for firms producing trucks, buses and automotive components, machine tools, cutting tools, heavy construction equipment and electrical equipment including cables and wires. The balance will be used for importing spares for heavy construction equipment.
