STATEMENT

The Defence Ministry is responsible for the defence of the country and in this context the responsibility for guarding the frontiers of India is ultimately their.3. The broad division of responsibility between the Ministries of Defence and Home Affairs in regard to guarding of our frontiers is that in normal times border defence which involves mostly police duties, i.e., checking of smuggling and infiltration, enforcement of customs and immigration laws, prevention of escape of offenders, and minor incursions by armed gangs are entrusted to the armed police units of the States concerned. Such enforcement of the law is essentially the task of the police and cannot be performed by the Army which is raised and trained with an entirely different objective. To that extent, the responsibility lies with the State Governments/Ministry of Home Affairs. However, when the country across the border is hostile and there develops a situation which is beyond the capacity of police to deal with, the Army takes over responsibility for defence of the border.

2. The co-ordination between the Ministries of Home Affairs and Defence in regard to the defence of borders and of border areas is secured through a variety of channels including Cabinet Committees, Official Committees frequent consultations, etc.
