SHRI GULZARILAL NANDA: There is a formal aspect which is being considered. In fact all the help that had been needed was given earlier, and will be given now.

SHRI BHUPESH GUPTA: In view of the facts and circumstances of the particular murder and also the political controversies that arose with regard to the possible motive behind ibis particular crime, may I know why the Government is not directly assuming the responsibility of conducting the investigation and taking it away from the hands of the Punjab authorities? What is there in the way? May I know why the Government did not act in this matter because it was not just a crime but it was a big thing that happened in the country? May I know why the Central Government only got associated with the investigation without responsibility for conducting it which is entrusted to the Punjab Government, over which also there is a controversy?

SHRI GULZARILAL NANDA: It is the same question put in other words. I think the decision 'of the Central Government has been justified by the outcome of the results, that is, the help being made available and coordination of effort also, and we have got our Director of Intelligence to take over. Therefore, this was the best method and therefore it was found to be fully/justified.

SHRI SANTOKH SINGH: Would it be possible to narrow down all the broad motives of the murder of Shri Pratap Singh Kairon to one central motive?

SHRI GULZARILAL NANDA: I do not think I need reply to that.

SHRI ARJUN ARORA: May I know if the Government of India is satisfied with the progress that is being made in the extradition proceedings in Kathmandu hecause the reports are that in the last hearing of these very

important proceedings nobody on behalf of the Punjab Government was present?

SHRI JAISUKHLAL HATHI: *Prima facie* the case that is going on in Kathmandu is not with regard to this case.

SHRI B. K. P. SINHA: The hon. Minister has rightly pointed out tliat motive cannot be isolated from the chain of events that culminate in an incident. Therefore, either the investigation is taken up as a whole by the Centre or not taken up at all. May I know why the Government are inhibited in taking up the investigation as a whole? I understand from his previous reply that they are inhibited because of a particular constitutional position that, law and order being a State subject, they cannot intervene. But mayi I inform the hon. Minister that in the U.S.A. where law and order is a State subject, when crimes have inter-State ramifications, as this crime has, they fall within the purview of the Federation? Therefore, would the Government reconsider their whole attitude in the light of this?

SHRI GULZARILAL NANDA: The matter is so advanced already in respect of investigation as such and with all that has been discovered I do not think there is any real necessity for doing so.

Mr. CHAIRMAN: Next question.

INCIDENTS IN AUROBINDO ASHRAM

an enquiry into the incidents which took place in Shri Aurobindo Ashram at Pondicherry;

- (b) Lt so, whether any enquiry has been held; and
- (c) if the answer to part (b) above foe i_n the affirmative, what is the Jesuit of the enquiry?

THE MINISTER OF STATE m IHE MINISTRY OF HOME AFFAIRS (SHRI JAISUKHLAL HATHI): (a) The Prime Minister asked the Home Minister to look info the demand *tar* making an enquiry into the incidents.

(b) and (c) Enquiry is in progress.

SHRI A. B. VAJPAYEE: May I know at what level the enquiry is being conducted and when the report is expected to be completed?

SHRI JAISUKHLAL HATHI: An officer 'of the status of Joint Secretary in the Home Ministry is doing it. And about the date I cannot today say anything but it should not take much time; in a month or so it should be done.

SHRI A. B. VAJPAYEE: May I know whether the Joint Secretary has been given any terms of reference and, if so, what exactly are the terms *>f reference and whether they include the alleged connivance of the Pondicherry police?

SHRI JAISUKHLAL HATHI: The terms of reference are: —

"(a) To enquire into and report on the causes and the course of incidents in Pondicherry on the llth February, 1965 including the attack en the Aurobindo Ashram."—

This includes what the hon. Member has. in mind—

"(b) To suggest measures necessary for preventing the recurrence of such incidents." 212 RSD—2.

SHRI A. B. VAJPAYEE: It is not a question of preventing any recurrence.

MR. CHAIRMAN: Item (a) is so general that it includes what you have in mind.

SHRI A. B. VAJPAYEE: I have my own doubts. If the Joint Secretary has not been clearly asked to fix up the responsibility for the failure of the administration, how can he go'out of his way and report on that matter?

SHRI JAISUKHLAL HATHI: Ho cannot directly be asked to report r>n the failure but he will certainly take into account all the incidents that happened and why they happened, if they could have been prevented, why they were not prevented, etc. All these he will certainly look into; we have told him fo look into.

SHRI S. S. MARISWAMY: Will he publish the Report when it is available, the Report of the enquiry?

SHRI JAISUKHLAL HATHI: After we get the Report, we shall consider it ...

SHRI S. S. MARISWAMY: Will you publish it?

SHRI JAISUKHLAL HATHI: We will consider it.

SHRI A. D. MANI: May! I ask the Minister why a District Judge was not asked to conduct this enquiry? Mr. Abraham who is one of those who has tabled this question made serisns allegations against the Ashram in this House and he attributed a number of motives to the Ashram and also described the circumstances in which the attack took place. The attack on the Ashram has created very unfavourable international repercussions outside India. Why can't the Government even at this stage order a judicial enquiry instead of asking a Jtoint Secretary to go into this matter?

SHRI JAISUKHLAL HATHI: So far as the offences that have been com-

mitted are concerned, I think about 46 persons are being prosecuted. So far as the judicial part is concerned, it will be taken care of. But here is a question; as Mr. Vajpayee said, it is more or less also an administrative matter and therefore we thought that an administrative officer would be better suited.

SHRI M. M. DHARI A: Has the Government received any interim Report in the matter or has the Government asked the authorities concerned to submit any interim Report?

SHRI JAISUKHLAL HATHI: No, Sir.
