सीमेंट कारपोरेशन सीमेंट के कारखानों
की स्थापना करने के लिए इस समय

विजली और पानी इत्यादि सम्बन्धी
दूसरी सुविधाओं के बारे में प्रारम्भिक
सर्वेक्षण करने के काम में लगा हुआ है।

engaged in the preliminary survey of the
availability of raw materials and other
facilities like transport, power, water, etc.,
for setting up cement factories; the places
where it would set up cement factories
can be decided only after the results of
the preliminary survey are known.

(b) The locations are proposed to be
selected on economic considerations,
viz., availability of raw

approved establishment of two new
factories—one in Gujarat and one in
U.P., for the manufacture of Baby Food,
and expansion of an existing unit in
Gujarat.

**ELECTRIFICATION OF RAILWAY

THE DEPUTY MINISTER in THE
MINISTRY OF RAILWAYS (SHRI SHAM
NATH): (a) The question of electrification
of Madras-Vijayawada section is being
examined in detail along with a few other
high traffic density trunk routes on the
Railways.

(fo) The inclusion finally of this
section in the 4th Plan electrification
programme and its phasing will depend
on the availability of funds, ot

power and on the relative priorities of the different sections as determined by the operating advantages and economics.

EXPORT OF 'BLEEDING MADRAS'

Of these, five applicants have already been approved by the Selection Committee for setting up industries in the Zone.
