THE MINISTER OF COMMERCE (SHRI MANUBHAI SHAH): (a) The following commodities are under compulsory quality control and pre-shipment inspection before export:

Bristles ~~Sann Hemp~~: Unmanufactured Tobacco; Raw Wool; Goat Hair; Sandal Wood Oil; Lemongrass Oil; Palmrosa Oil; Black Pepper; Cardamom; Chillies; Myrobalan; Cashew Kernels; Walnuts; Table Potatoes; Vegetables Oils: viz. Castor Oil Refined Safflower oil, Refined Cotton Seed Oil, Linseed Oil (including refined oils), Groundnut oil; Hydrogenated vegetable oil; Vetiver Oil; Mica all forms (other than mica and mica products, fabricated mica parts and mica powder); Salt; Etawah Bedsread (Handloom); Bleeding Madras (Handloom); Tussar Silk fabrics; Woollen fabrics; Woollen yarn and woollen hosiery; Rayon and synthetic fibre goods; Jute hessian; Heavy Cee Jute bags; A-Twill jute bags; Jute corn sacks; Aluminium Utensils; Teachest Plywood; Frozen Prawns; Prawns canned in brine or dry packed; Animal casings; Fruit & Vegetable Products; Steel sections; Drugs and Pharmaceuticals under the Drug Act.
