THE MINISTER OF STEEL AND MINES (SHRI N. SANJIVA REDDY): (a) and (b) In the mechanised mines of Rajhara (iron ore) and Nandini (limestone), the raising 'of ore is undertaken departmental labour. The through output of these mechanised mines is however, not adequate to meet the increasing raw material requirements of the Bhilai Steel Plant. Steps are in hand to extend mechanised mining facilities, for iron ore at Rajhara and Dalli and for limestone at Nandini. It would take some time for these facilities fo be installed. In the intervening period, the increased iron ore and limestone requirements are being met by manual mining, for iron ore at Dalli and for limestone at Nandini. Since these arrangements are purely temporary and for a short period contract labour has been engaged. However, every effort is being made to restrict the employment of contract labour to the minimum number and to the shortest duration. Welfare amenities for the contract labour are either directly by the plant or provided in terms of the contracts.

2. The operations in the Hirri Dolomite Mines are of an intermittent character an<sup>^</sup> the employment of labour varies very widely over the year. In view of the intermittent nature of the mining, the raising is done through contract labour. Nevertheless, steps to mechanise the mine are in hand.
