ministrative, the language to be used in various documents lists, labels, etc. should continue to be the language which was currently in use before January 26, 1965."

May I point out that if before 26th January only English was being used, is it not necessary that after 26th January, along with English, Hindi should also be used?

SHRI GULZARILAL NANDA: Hindi was being used before. The hon. Member, if he goes behind the circular and sees the collection of the circulars, will find that there is provision for the use of Hindi in many cases and that will continue; and any further progress in this direction is now being considered by us in regard to the application of the language policy

SHRI BHUPESH GUPTA: May I invite the attention of the hon. Minister to the earlier circular referred to by the hon. Member Shri Vajpayee and point out that it says:

"It has come to the notice of Government that two Hindi communications were sent by an office under the Central Government to States in non-Hindi-speaking areas without enclosing their English versions.

It is requested that the Ministry of Finance etc., may kindly issue suitable instructions to all offices under them so as to ensure that all communications to non-Hindispeaking States are sent in English or with an authorised translation in English."

So, Mr. Vajpayee was committing the same thing which the hon. Home Minister does, suppressio veri suggestio falsi. Here the circular seems to be concerned only with sending Hindi communications to non-Hindi-speaking regions.

MR. CHAIRMAN: I thought you wanted to know something.

SHRI BHUPESH GUPTA: So, I would like to know how it is that the hon. Minister of Home Affairs does not know this circular issued by his Ministry and fumbles on such a matter as he does on many other questions?

SHRI GULZARILAL NANDA: The only thing I want to point out, Sir, is that the art of suppressing truth of killing and murdering truth is a special art known to the friends of the hon. Member and it is their monopoly and we have nothing to do with that. Of course, I do not know by heart every circular, but I know the policy and therefore I could challenge and say that there was no such circular at all.

STANDING COMMISSION FOR SCIENTIFIC
AND TECHNICAL TERMINOLOGY

*269. SHRI M. P. BHARGAVA: Will the Minister of Education be pleased to state:

- (a) the present strength of the members of the Standing Commission for Scientific and Technical Terminology;
- (b) whether the said Commission has been directed to take un the work of the evolution of Terminology in Humanities also; and
- (c) what is the strength of the staff of the said Commission as on 1st April, 1965?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION (SHRI BHAKT DARSHAN): (a) The present operative strength of the Members of the Commission is 7.

- (b) Yes Sir.
- (c) No separate staff has been sanctioned for the Commission. The staff of the Central Hindi Directorate functions as the Secretariat of the Commission.

SHRI M. P. BHARGAVA: May I know how long this Commission has been at work and whether this Commission has been constantly writing to the Government that enough working facilities are not being provided to it?

Shri BHAKT DARSHAN: Sir, this Commission was established by Presidential Order dated the 27th April, 1960. But actually, it started functioning from the middle of 1962. As regards accommodation and other difficulties, they have been representing to the Ministry and we have taken some decisions recently which, I hope, will go a long way in solving these difficulties.

SHRI M. P. BHARGAVA: May I know when was the work of preparing the terminology for Humanities entrusted to the Commission for Scientific and Technical Terminology?

SHRI BHAKT DARSHAN: Sir, it was in April 1963. The former committee under the chairmanship of Shri Ramdhari Singh Dinkar was wound up and the work was entrusted to this Commission.

Shri M. P. BHARGAVA: Who are the members out of this present number of seven who represent the Sciences and the Humanities?

SHRI BHAKT DARSHAN: For Humanities there are two Members at present—Maj. J. S. Guleri who is looking after Economics and the Social Sciences and there is Prof. P. S. Naidu for Philosophy and other allied subjects.

श्री विमल कुमार मन्नालालजी चौरड़िया: क्या श्रीमान् यह बतलाने की कृपा करेंगे कि इस ग्रायोग ने इन 5 मालों में कितना कार्य किया है?

श्री भक्त दर्शन : श्रमन्, मुझे यह निवेदन करना है कि इस ग्रायोग को ाम करते हुए 5 साल नहीं ुए हैं बिल्क 3 सात हुए हैं पहला वर्ष को तारी में लग गया और अब तक की प्रगित इस प्रकार है। इस प्रायोग ने 15,000 शब्दों की एक इंग्लिश हिन्दों डिक्श-नरी अभी हाल ही में प्रकाशित की है। इसके सिवाय मेडिकल साइन्स के बारे में करीब 14,000 शब्दों और अग्रिकल्चर के बारे में करीब 14,000 शब्दों और अग्रिकल्चर के बारे में करीब 4,000 शब्दों को छाटने का कार्य पूरा कर लिया है। इसके सिवाय रुड़की यूनिवर्सिटी के सहयोग से इंजीनियरिंग विभाग में काम आने वाले शब्दों के सम्बन्ध में कार्य किया जा रहा है। जहां तक एडिमिनिस्ट्रेटिव टरिमनालोओं का सम्बन्ध है, उसके बारे में हाल ही में को पुस्तकें प्रकाशित की गई है।

DR. SHRIMATI PHULRENU GUHA: The hon Minister mentioned the names of only two members. May I know the names of the other five members?

SHRI BHAKT DARSHAN: Formerly Sir Dr. Kothari was the Chairman of this Commission. He had to resign after his appointment as the Chairman of the Education Commission. Now Dr. K. K. Sethi is the acting Chairother members The Dr. Balasubramaniam for medicine, Shri B. N. Khatri for Engineering, and then, as I have already said, there is Maj. Guleri for Social Sciences and then Prof. P. S. Naidu for philosophy, Dr. D. V. Bal for biological sciences and Dr. B. N. Prasad is Member Secretary; he is also in charge of linguistics.

Shri N. SRI RAMA REDDY: I would like to know when this Commission is likely to complete its work. It seems a certain amount of reviewing has got to be done because of the progress made in the humanities and technology all over the world and so has not the Commission to be put on a permanent footing on account of the importance of the work that it has to do?

SHRI BHAKT DARSHAN: Sir, the very name of the Commission shows that it is a standing commission and it is more or less permanent. But we do not envisage that it should be really permanent in that sense, because we are hoping that by the end of the Fourth Plan the major portion of the work will be completed.

प्रो॰ सत्यवत सिद्धान्तालंकार: इस उतर से यह स्पष्ट हो जाता है कि ह्यू मैनिटीज का काम इस कमीक्षन को दिया गया है। तो क्या माननीय मन्त्री जी यह बतलाने की कृपा करेंगे कि ह्यू मैनिटीज के बारे में शब्दकोष कौन कौन सी संस्थाएं बना रही हैं? अलग अलग संस्थाएं यह कार्य कर रही हैं तो क्या यह जुपलिकेटिंग नहीं हुआ।?

श्री भक्त दर्शन : श्रीमन्, जितनी भी संस्थाएं इस तरह का कार्य कर रही हैं वे इस कमीशन के तत्वाधान में ही कर रही हैं। ग्रौर कमीशन उन संस्थाग्रों को सहयोग ग्रौर ग्राथिक सहायता देता है।

प्रो॰ सत्यव्रत सिद्धान्तालंकार : ग्रगर ये संस्थाएं भी इसी तरह का कार्य कर रही हैं तो इपलिकेटिंग ही हुग्रा ?

श्री भक्त दर्शन : श्रीमन्, जहां तक मेरी जानकारी है, इस तरह की शब्दावली बनाने का कार्य किसी ग्रीर संस्था द्वारा नहीं हो रहा है। हो सकता है कि वे लोग पुस्तकों के प्रकाशन का कार्य कर रहे हों।

श्री ग्राबिद श्रली: शब्दकोश इस तरह से छापे जाने चाहियें जिससे सब लोग उनके शब्दों को श्रासानी के साथ समझ सकें क्योंकि यह साइन्टिफिक शब्दों का मामला है। इस तरह के शब्द "मानव रक्त पिपासू सत पद कीट" का इस्तैमाल नहीं किया जाना चाहिये जो कि बहुत ही मुश्किल है। इस शब्द का मतलब खटमल होता है। इर इस बात का है कि श्रगर साइन्टिफिक टरिमनलोजी में भी इसी तरह के शब्द हुए तो उन्हें समझना मुश्किल ही जायेगा।

श्री भक्त दर्शन: श्रीमन्, मैं इस सम्बन्ध में यह निवेदन करना चाहता हूं कि माननीय सदस्य ने जिस भव्द का उल्लेख किया है, उसका साइंस से कोई सम्बन्ध नहीं है। यह साधारण बोलचाल का शब्द है। जिस शब्द का उन्होंने उल्लेख किया है, यह शब्द कम से कम शिक्षा मन्द्रालय के शब्दकोश में नहीं है। हो सकता है कि डा० रघुवीर अथवा उनके चेलों ने ऐसा कोई शब्द घटा हो।

श्री ए० बी० वाजपेयी : डा॰ रघुवीर को क्यों घसीटते हो ।

Prof. B. N. PRASAD: For certain subjects the Commission has appointed one full member. For science, which is a very broad group, there is only one member with the result that work on scientific terminology is not supposed to be as satisfactory as it should have been. The Commission had drawn up a list of certain number of words in 1962 but even up to now we have not got them, a full printed list.

MR. CHAIRMAN: What is the question Dr. Prasad?

Prof. B. N. PRASAD: I would just state the fact and then ask the question. There are a number of higher branches of science on which no work at all has been done. I would like to know from the hon. Minister what steps he is going to take to stimulate more work on the subject.

Shri M. C. CHAGLA: May I say that the whole thing is being reorganised? We received the report only a few days back and I have appointed a committee to go into this. The work of the Hindi Directorate and this Institute has been separated. We are going to implement this and I assure my hon. friend that there will be much greater despatch in the execution of work than has been the case in the past. Work has been slow and I am not satisfied. Therefore, I have appointed this committee and I assure

my hon, friend and the House that shall see that this work is expedited as much as possible.

श्री भगवत नारायण भागव : क्या सर-कार ने कोई परिपत्न कर्मचारियों के नाम इस बात को जानने के लिये भेजा है कि उनके ऊपर कितना कितना कर्ज़ा है ?

श्री ललीत नारायण मिश्रः जी हां, बात ऐसी है कि कुछ दिन पहले गृह मंत्री जी को यह स्याय हुआ था कि य जो हमारे कर्मचारी है, जिन की तनस्वाह 500 रु० महीन फे कम है, उनकी श्राधिक हालत श्रच्छी नहीं रहती है भौर उनको ज्यादा सुद देकर कर्ज लेना पड़ता है, इसलिए जहां तक सम्भव हो उनको सरकार की तरफ सं रिम्रायत से कर्जा दिमा जाय। इसके लिये एक सर्वे किया गया, लिकन इस योजना को सभी स्रन्तिम रूप नहीं दिया गया है। हमारा यह विचार है कि हमारे ऐसे मलाजिम जिनकी ग्रामदनी 500 रु० महेना या 6,000 रु० सालाना संकम है, उनकी मदद की जाय।

थी भगवत नारायण भागव : मन्त्री महो-इय ने यह कहा कि इसको अभी अन्तिम रूप नहीं दिया गया है, मैं यह जानना चाहता हूं कि प्रभी इसमे कितना समय लगेगा जब यह योजना को मन्तिम रूप दिया जायेगा ?

श्री ललित नारायण मिश्र : ग्रभी यह कहना कठिन है स्योंकि बहुत से भ्रांकड़े इकट्ठे करने है ग्रौर बहुत बातों को देखना है।

SHRI BHUPESH GUPTA: May know why it should not be possible for the Government to settle this matter by giving some immediate relief in consultation with the representatives of the recognised Central Government employees' Union and why should not the Government make certain funds available in order to help these low paid employees?

SHRI L .N. MISHRA: We have accepted that there is need. At our instance, this question was taken up and we are at it. I believe that we will be able to do something for these people.

SHRI ARJUN ARORA: May know if the Government have examined the advisability of giving the
