- ic) The above mentioned benefits are | admissible to India-based Class IV staff' only and these had to be withdrawn when it was found that the locally recruited Class IV personnel were enjoying the same erroneously.

- (a) the details of the scheme for the merger of the postal life insurance scheme with the Life Insurance Corporation; and
- (b) the estimated amount of expenditure likely to be saved *on* account of the merger?]

संचार विभाग में उपमंती (श्री बी० भगवती): (क) डाक जीवन बीमा को जीवन बीमा निगम में मिलाने की कोई योजना सरकार के विचाराधीन नहीं है। कुछ समय पूर्व इस प्रस्ताव की जांच की गई थी और यह निश्चय किया गया था कि इस योजना को अलग ही रखना सरकारी कर्मचारियों के हित में होगा और यदि इसे मिला दिया गया तो डाक जीवन बीमा के बीमेदारों को जो कुछ सुविधाएं इस समय उपलब्ध हैं, वे वापस ले ली जायेंगी।

(ख) डाक जीवन बीमा की व्यवस्था पर होने वाला समूचा खर्चा डाक जीवन बीमा निधि के नामें लिखा जाता है। अतः खर्च

की बचत का कोई प्रश्न ही नहीं उठता। वास्तव में डाक जीवन बीमा निधि के खर्चे का अनुपात जो इस समय 7.05 प्रतिशत है बढ़कर कुल मिलाकर 27-5 प्रतिशत और नवीकरण-खर्च 12.46 प्रतिशत हो जाने की सम्भावना है, जो कि जीवन बीमा निगम के खर्चे का मौजदा अनपात है।

fTHE DEPUTY MINISTER IN THE DE-PARTMENT OF COMMUNICATIONS (SHRI B. BHA.CJAVA.TI): (a) No Scheme for ihe merger of the Postal Life Insurance with the Life Insurance Corporation is under consideration of the Government. The proposal was examined in the past and it was decided that it would be in the interest of Government servants to continue it as a separate entity and that merger would result in withdrawal of certain facilities now enjoyed by P.L.I, insurants.

lb) The entire expenses of management $o \setminus$ the Postal Life Insurance are debited to the Postal Life Insurance Fund. The question of saving in expenditure does not therefore arise. In fact the expense ratio o!' ihe P.L.I, fund which is at present 7-05% is likely to go up to 27-5% overall and 12-46% renewal, the present expense ratio of the L.I.C.]

THE DEPUTY MINISTER IN THE MIN-ISTRY OF HEALTH (SHRI P. S. NASKAR): The Central Health Service Rules which were under discussion for about 7 years were issued on the 1st of May, 1963. These rules provide for the formation of a Service with 5 categories of officers with pay scales as

follows:

matter of urgent

public importance

Category A-Rs. 1600-100-2000. Category B-Rs. 1300-60-1600. Category C-Rs. 675-35-850-40-1050' -50-1300.

D—Rs. Category 425-25-450-30-600-35-705-EB-35-950.

325-25-500-30-Category E-Rs. 590-EB-30-800.

In addition to these scales, the post of Director General of Health Services carries a salary of Rs. 2.750 (Non-I.M.S.), All the posts in the Service carry a non-practising allowance of 25 per cent, of pay subject to a minimum of Rs. 150 anil a maximum of Rs. 400. The Service consists of about 2.300 posts which includes posts under the Ministry of Health including posts under the Central Government Health Scheme, Ministry of Labour and Employment, Ministry Community Development and Co-operation. Ministry of External Affairs, the Ministry of Home Affairs, the Delhi Administration and other Union Territories, Delhi Municipal Corporation, the New Delhi Municipal Committee, the Lady Hardinge Medical College and Hospitals, etc. The posts include leaching posts as well as general posts and the officers are liable to be posted anywhere in India to serve the needs of the different agencies mentioned above. The Rules provide for promotion of officers in the various scales in addition to a small quota of direct recruitment. The postings of officers to different posts will be based upon the requirements of the Service from time to time

The Central Government Health Scheme Medical Officers' Association submitted a representation on the 30th July 1963 raising certain points in regard to the Central Health Service Rules, 1963. The points were examined in the Ministry of Health and a reply was sent to the Association
