RIOTS IN LACCADIVE AND MINICOY ISLANDS

j Shri RAM SINGH : $^{\mathrm{Z5Wl}}$ \ SHRI U. S. DUGAL:

Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether it is a fact that some Pakistani agents provoked riots in Laccadive and Minicoy Islands preventing people Irom taking part in the Republic day celebrations arul currently they are propagating anti-Indian feelings among the people there; and
- (b) if so, what steps Government propose to take to stem the evil?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI JAISUKHLAL HATHI): (a) and (b) Certain persons of Bada village in Minicoy, in consequence of the instigation by some sailors who worked on foreign ships and who had returned home on leave, had threatened students and others not to participate in the Republic Day functions. Subsequently on 4th February, 1965, when two ring leaders including a sailor were being interrogated in the police station, a crowd tried to attack the police station and disturb public peace. 32 persons are being prosecut-
