THE MINISTER OF HEALTH (DR. Sushila Nayar): (a) and (b) A statement showing the Statewise Central allocations for the Third Plan, the amount provided for the period ending March, 1965 and the estimated expenditure for period is laid on the Table of the Sabha. The expenditure in the earlier years of the Plan is normally at a lower rate than in the final years. Consequently the expenditure in the last two years of the Plan are expected to be at a much higher rate. Besides, the Family Planning programme was re-organised in October, 1963. State Governments are adopting the organised programme, but have not done so fully in all cases. It is expected that they will all do it during the last year of the Third Five Year Plan.

THE MINISTER OF HEALTH (DR. SUSHILYA NAYAR): (a) Yes, Sir.

(b) Oral progestins are not allowed to be sold in market as drugs for control of conception. Some synthetic progestines are allowed only for clinical testing as oral contraceptives. In view of the available evidence of effectiveness of these drugs for disturbances of menstruation, sterility and other gynaecologic purposes for which their use is for short duration their sale for therapeutic purposes only on medical prescription is permitted. The Drugs troller of India is imposing the necessary restrictions and precautions while permiting the sale of these products. The sale of these drugs for control of conception is not yet allowed in India,

## COORDINATED RAIL-ROAD TRANSPORT SYSTEM

## STATEMENT

The broad approach being followed in the formulation of transport development programmes in the Fourth Plan is that various transport services should be developed as integral parts of a composite transport network and operated so as to ensure that each form of transport is put to the maximum advantage from the point of view of the economy as a whole. An attempt is being made to prepare a transport plan in broad outline for the period ending 1975-76 and in detail for the period of the Fourth Plan. With a view to drawing up the long-term transport plan which takes an integrated view of railway and road transport and other transport services, a systematic programme of technical and economic studies has been initiated in the Planning Commission, the Ministries Railways and Transport and the States. These studies include assessment of transport requirements of bulk commodities and
