May I ask the Minister why the Government is not trying to consider the possibility of enforcing the policy of price control, in view of the fact that he himself recognises that there is shortage and the goods go underground and the prices are pushed up?

SHRI T. N. SINGH: I think the present system whereby the manufacturers have come to an agreement to impose price control is working better and before we step in, we should watch the progress of this system.

SHRI FARIDUL HAQ ANSARI: May I know whether the hon. Minister is aware that there was a great deal of shortage of baby food in Delhi and also in U.K.? May I know whether in these two States any stock has been confiscated?

SHRI BIBUDHENDRA MISRA: To our knowledge, no stock has been confiscated in these two States.

SHRI N. SRI RAMA REDDY: 1 would like to know from the Minister what special facilities he is going to provide for this industry, whether it be in the private sector or in the co-operative sector, to the new enterpreneurs that are likely to come into the field?

SHRI T. N. SINGH: There is nothing like any very particular, special facilities except that the dairying arrangements should be encouraged in those areas, that there would be proper animal husbandry practices etc. That should be done. Otherwise, the enterpreneurs on their own can go ahead and make improvements.

*415. SHRI M. C. SHAH: Will the Minister of INDUSTRY AND SUPPLY be pleased to state:

(a) whether Government have any proposal under consideration to start a factory for manufacturing medium size tractors; and

(b) if so, whether any foreign collaboration for this project has been decided?

THE DEPUTY MINISTER IN THR MINISTRY OF INDUSTRY AND SUP-PLY (SHRI BIBUDHENDRA MISRA): (a) Yes. Sir.

(b) Not vet. Sir.

SHRI M. C. SHAH: May I know what will be the annual production of this factory and where it is to be located?

SHRI BIBUDHENDRA MISRA: There are now three collaboration offers under consideration. In one case, the feasibility report has been received and the Government of India has given its comments.

We are awaiting the reply. In the two other cases the feasibility report is to be Unless that is done it will be prepared. difficult to say about the capacity that is to be installed and also the place where it will be located.

SHRI M. C. SHAH: May I know the foreign exchange component involved in this?

SHRI T. N. SINGH: I think we should await the three Project Reports before committing ourselves in figure about the foreign exchange.

SHRI M. C. SHAH: In view of the fact that in our country there are small farms of about five acres or less in millions in number, may I know whether the Government will consider the point that these tractors will have to fulfil the requirements of these small farms?

SHRI T. N. SINGH: All these schemes that are there whether for tractors or for power tillers are being considered in full consultation with the Agricultural Ministry and with their approval only these will be taken up.

SHRI ARJUN ARORA: May I know which are the three countries with which the Government of India is pegotiating or somebody is negotiating for collaboration?

SHRI BIBUDHENDRA MISRA: One is the Czech offer, the other is the Russian offer and there is also the French offer.

SHRI M. M. DHARIA: In view of the fact that this country is passing through a critical stage so far as food shortage is concerned, will the Minister assure this House that the factory for manufacturing these small tarctors will be established as early as possible?

SHRI T. N. SINGH: It can only say that because of the urgency we have decided to take up this project in the public sector and that shows the measure of seriousness that Government attaches to this.

Shri I. K. GUJRAL: In view of the fact that it is recognised that the tanks and tractors are very near each other mechanically speaking-and in the last Great War this was a very big second line of defence in England particularly-may I ask the hon. Minister if he is exploring the possibility of linking up this scheme with the tank production factory being set up in the South?

SHRI T. N. SINGH: I think it will be very difficult to answer this question particularly as I would like to consult the Defence Minister before saying anything about this

SHRI N. SRI RAMA REDDY: I would like to know if any assessment of the requirements of the tractors in this country has been made. How many of them are going to be produced and in how many Plans will the entire requirements be met?

SHRI BIBUDHENDRA MISRA: The Third Plan target was 10,000 in number per annum and it is now estimated both by the Planning Commission and in consultation with the Ministry of Agriculture also that the Fourth Plan target so far as the tractors are concerned-I am not speaking of power tillers-will be about 40,000 per annum and the licence. . . .
