

SHRI RAM SUBHAG SINGH: We are very much in the picture. When I said the Transport Ministry, by that I also meant the entire Government and the Railways will also be consulted. We ourselves would like to take interest in that but primarily it will have to be dealt with by the State Government, the Planning Commission and the Transport Ministry though the Railways will also be there.

SHRI D. L. SEN GUPTA: The entire passenger traffic emanating from Calcutta has to go through that one-way traffic, the Howrah bridge to reach Howrah station. In consideration of all the difficulties and till alternative arrangements are made, would the Government be prepared to start at least some of the trains like the De Luxe Express, the Delhi Mail, the Delhi Express and the Janata Express— these four trains—from Sealdah Station «instead of from Howrah?

SHRI RAM SUBHAG SINGH: That is a suggestion which we will take into consideration but so far we have been starting trains according to the convenience of the different areas as well as passengers.

SHRI BIREN ROY: In view of the fact that all the residents of Calcutta and the surrounding municipalities have been paying tax for the construction of the Howrah bridge and in view also of the fact that now not only the money spent has been realised but that there is a lot of credit now being deposited— and this tax is still being realised—will that money be utilised by the Centre to put up a new bridge?

SHRI RAM SUBHAG SINGH: That money is not realised by the Railways.

MR. CHAIRMAN: The Question Hour is over.

^INDIAN RAILWAYS' ACT

214. SHRI T. V. ANANDAN: Will the Minister of RAILWAYS be pleased to state:

(a) whether it is a fact that light railways owned by private employers in India were exempted from Chapter 6 (a) of the Indian Railways' Act (Hours of Employment Regulation);

(b) if so, what were the reasons for granting such exemption;

(c) what is the total number of employees on the aforesaid light Railways;

(d) out of those employees what is the number of employees working less than nine hours and more than nine hours a day;

(e) whether those working over 9 hours a day are paid overtime; and

(f) if so, at what rate?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAM SUBHAG SINGH): (a) and (b) Yes, because the financial position and the working conditions of these light railways were such that they would not be in a position to bear the burden of implementing this legislation on their systems.

(c) and (d) On 1st January, 1965 there were 4,637 employees on these light railways and out of these, 2,849 work less than 9 hours a day and 1,788 work more than 9 hours a day.

(e) and (f) On the Ahmedpur-Katwa, Burdwan-Katwa and Bankura-Damodar River light railways managed by M/s. McLeod & Co., Ltd. for each hour of overtime work payment is made at 1/8th or 1/12th of a day's basic pay for work done beyond 8 hours or 12 hours per day as the case may be. On the Futwah-Islampur, Howrah Amta, Howrah-Sheak-tiala, Arrah-Sasaram light railways managed by M/s. Martin Burn Ltd., overtime payment is made at ordinary rate of pay over 84 hours' work in a week and on the Shahdara-Saharanpur light railway, overtime is paid at the same rate over 75 hours' work in a week.

RECOMMENDATIONS OF EXPORT-IMPORT ADVISORY COMMITTEE

THE MINISTER OF COMMERCE (SHRI MANUBHAI SHAH): (a) Yes, Sir. The meeting of the Export-Import Advisory Council was held on the 15th and 16th February, 1965.

(b) A copy of the proceedings of the meeting has already been placed in the Parliament Library.

(c) The various suggestions received from the Members of the Council were included in the Agenda papers, a copy of which has been placed in Parliament Library. The reaction of the Council to these suggestions is given in the proceedings of the meeting which has already been placed in the Library.

ALLOTMENT OF G.C.I. SHEETS TO STATES

THE MINISTER OF STEEL AND MINES (SHRI N. SANJIVA REDDY): (a) and (b) No fresh allocation of galvanised Corrugated Sheets has been made since April, 1962 because of the large backlog of orders on the main producers- However, supplies to the various States are being made to the extent possible against their outstanding orders.
