Division Clerks whereas the Lower Division Clerks borne on the Central roster with 20 years of service have neither been confirmed nor have been promoted as Upper Division Clerks;

- (c) whether any representation has been received from the staff in this regard; and
- (d) if the answer to part (c) above be in the affirmative, the action taken thereon?

THE MINISTER OF DEFENCE (SHRI Y. B CHAVAN): (a) and (b) This is so only in respect of Nos. 1, 2 and 3 Field Ordnance Depots. This position arisen because the clerical staff employed in Field Ordnance Depots are borne on the Unit-wise Roster whereas the clerical staff in other Ordnance Depots are borne on the Central roster.

(c) Yes, Madam.

(d) The question of merger of staff in the Field Ordnance Depots who are borne on the Unit roster with similar staff in other Ordnance Depots borne on the Central roster had been examined but could not be accepted on account of the various administrative and practical difficulties.

SHORTAGE OF FERROUS SCRAPS ON STOCK VERIFICATION

*502. THAKUR **BHANU** PRATAP SINGH: Will the Minister of COMMUNICA-TIONS be pleased to state:

- (a) whether it is a fact that on a stock verification in 1958 in a workshop a shortage of about 80 tons of ferrous scraps valued at Rs. 28,000 was found; and that after an enquiry made in 1963 the responsibility for misappropriation of the shortage in the stock was fixed on a gazetted officer; and
- (b) if so, what action has been taken against that officer?

THE DEPUTY MINISTER IN THE DEPARTMENT OF COMMUNICA-TIONS (SHRI B. BHAGAVATI): (a) Yes, Madam. Shortage of 73 tons 13 cwts. 1 grs. and 13 lbs of ferrous scraps M.S. cut pieces valued at Rs. 24,708.51 Paise was detected as a result of annual independent stock verification in July, 1958. The case was investigated and disciplinary action was initiated against three gazetted officers and three non-gazetted officials.

(b) Of the three gazetted officers, the case against one officer has been finalised and Government's displeasure has been communicated to him for the negligence exhibited by him in his supervisory duties. The case against other two officers is at present under reference with the Central Vigilance Commission. As regards nongazetted officials, one official has been compulsorily retired from service. The second official has been reduced in the time scale by one stage for a period of aix months. The third official has been exonerated of the charge against him.
