

THE DEPUTY MINISTER IN THE MINISTRY OF INDUSTRY AND SUPPLY (SHRI BIBUDHENDRA MISHRA) : (a) and (b) In view of the inadequate growth of some industries producing essential consumer goods, the development of these industries in the public sector is now under consideration. The details of the proposals have yet to be worked out.

**BROAD GAUGING OF POONA-MIRAJ RAILWAY TRACK**

/SHRI D. B. DESAI : \ SHRI M. M. DHARAI:

Will the Minister of RAILWAYS be pleased to state :

(a) what is the estimated amount of expenditure for broad gauging the Poona-Miraj Railway track;

(b) what amount will be spent upto March 1965; and

(c) what is the time schedule for completing the work ?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI SHAM NATH) : (a) The conversion of the Poona-Miraj M. G. section to broad gauge is estimated to cost Rs. 15-39 crores.

(b) An expenditure of about Rs. 180 lakhs is likely to be incurred upto the end of March 1965 on this project.

(c) The conversion work is expected to be completed by December, 1967.

**DECLARATION OF POONA-LONWALA AND POONA-LONI RAILWAY AREA AS SUBURBAN AREA**

(b) The cut has been applied in view of the difficult foreign exchange position.

(a) whether it is a fact that certain applications for Industrial Licence under Industries (Development and Regulation) Act have recently been received by the Government; and
