†[Allocations for Chitrakot Hydel Project sanctioned by Rehabilitation Ministry

- 721. SHRI G. K. KAPOOR: Will the Minister of Rehabilitation be pleased to state:
- (a) whether it is a fact that the team of experts has submitted its report to Government in which they have recommended that the work relating to the Chitrakot Hydel Project should be pursued further;
- (b) whether it is also a fact that the State Government has asked the Central Rehabilitation Ministry for additional outside the plan allocations for completing the work relating to this project in order to provide employment to displaced persons; and
- (c) if so, by what time this amount is expected to be sanctioned?

पुनर्वास मंत्री (श्री महावीर त्यागी (क) इन्द्रावती-सावरी बेसिन के सम्बन्ध में सिंचाई तथा जल विद्युत् संभाव्य के मूल्यांकन के बारे में जो टीम नियुक्त की गई थी, उसने मसौदे की रिपोर्ट तैयार कर ली हैं। श्रागे टीम के सदस्यों में बातचीत चल रही है श्रीर ग्राशा है कि शीघ्र ही रिपोर्ट को श्रन्तिम रूप दे दिया जायेगा।

(ख) राज्य सरकार ने यह सुझाव दिया था कि चिवकोट जल विद्युत् प्रोजेक्ट जो कि केन्द्रीय जल तथा विद्युत् श्रायोग की संदर्भ योजना में सिम्मिलित था ग्रौर जिसकी ग्रनुमानित लागत लगभग 7.60 करोड़ रुपये थी, इसके कार्य को ग्रारम्भ करने के लिये योजना ग्रायोग द्वारा योजना के ग्रातिस्कत त्वरित केन्द्रीय सहायता दी जाये। राज्य सरकार ने यह बताया है कि निर्माण कार्य में लगभग 3,000 विस्था-पित व्यक्तियों को 3 वर्ष की ग्रवधि के लिये रीजगार दिया जायेगा।

(ग) राज्य सरकार की प्रार्थना पर रिपोर्ट प्राप्त होने के बाद टीम की म्रन्तिम रिपोर्ट पर किये गये निर्णयों के म्राधार पर ही विचार किया जायेगा।

†[THE MINISTER OF REHABILITA-TION (SHRI MAHAVIR TYAGI): (a) The Team appointed for the appraisal of irrigation and hydro-electric potential of the Indravati-Sabri basin has completed its work and has prepared a draft report. Further discussions amongst the members of the Team are taking place and the report is expected to be finalised shortly.

- (b) The State Government had proposed that the Planning Commission should make available accelerated Central assistance outside the Plan to start work on the Chitrakot Hydro-electric Project which was included in the perspective plan of the Central Water & Power Commission and which was estimated to cost about Rs. 7.60 crores. The State Government had indicated that construction works would provide employment to approximately 3,000 displaced persons for a period of three years.
- (c) The request of the State Government will be further considered in the light of the decisions taken on the final report of the Team, after the report is received.]
