The information is furnished for the years 1962-63, 1963-64 and 1964-65 as the grants are given for the financial years but not for the calendar years.

SHRI P. K. KUMARAN: Sir, the Statement says that some 3,000 odd organisations have been given grants and the answer to part (b) of the question says that the information is being collected. When there are only some 3,000 institutions or organisations, was it difficult for the Government to find out how many of them are living, how many are dead and how many were unborn?

SHRI JAGANATH RAO: Some are born and some might have died. But the difficulty is that these organisations are situated in various parts of the country and the State Welfare Boards have been addressed by the Central Social Welfare Board and the information has not yet been received. I can assure the hon. Member that I will lay on the Table of the House the information as soon as it is received.

SHRI P. K. KUMARAN : What is the total amount involved ?

SHRI JAGANATH RAO: I think it is about—and I am speaking from memory — Rs. 200,00,000 under the various schemes, all together.

SHRI M. P. BHARGAVA: May I know whether it is the practice in the Central Social Welfare Board to get utilisation certificates of the funds allotted to the various institutions, and if that is the practice, whether utilisation certificates in many cases have not been received?

SHRI JAGANATH RAO: I have no such information with me.

SHRI G. MURAHARI: I would like to know from the Minister as to the criterion employed for granting such aid, and whether there has been any complaint of favouritism in the deployment of these funds.

SHRI JAGANATH RAO : No such complaints have been received by the

Ministry. I do not know if any complaints have been received by the Central Social Welfare Board. The application lor any grant or aid is made to the Slate Social Welfare Board. That Suite Board recommends to the Central Social Welfare Board and the sanction is given by the Central Social Welfare Board.

SHRI G. MURAHARI : Will you make enquiries into this ?

SHRI JAGANATH RAO: Yes, the State Social Welfare Board undertakes the enquiries.

SHRI OM MEHTA: How many instituiions in Jammu and Kashmir are receiving aid from this Board?

SHRI BHUPESH GUPTA: The Mims-ter said that he had not, the Ministry had not received complaints. Do T understand

that when complaints are received by the Board, they are not brought to the notice of the Ministry? Are we expected to reconcile to the position that the Ministry is also ignorant about the complaints being made, as is suggested in the reply to the question?

SHRI JAGANATH RAO: No complaint has been received by the Ministry. That is what I said. I do not know whether it has been received by the Central Social Welfare Board.

MR. CHAIRMAN: Whether complaints received by the organisation concerned are passed on to the Ministry or not—that is what he wants to know.

SHRI JAGANATH RAO: No, they are not passed on.

SHRI BHUPESH GUPTA: Therefore, i take it that even if serious complaints come about political patronage under the cover of this, the matter will not have been brought to the notice of the Minister. Is that right?

SHRI JAGANATH RAO: Unless any complaint is referred to the Ministry, 1 take it that the Central Social Welfare Board has such authority to go into the question.

SHRI AR.IUN ARORA: May I know it the Government is aware of the fact that this Board has earned the reputation of granting aid to those willing to buy vehicles of all sorts and, if so, will the Government please tell the House the number of vehicles for which grant or subsidy was given by this Board during the last one year or so?

SHRI JAGANATH RAO: I may inform the House that after the proclamation of emergency, vehicles are not allowed to be purchased.

SHRI A. B. VAJPAYEE: Is the Minister aware that the Central Social Welfare

Board has been granting large amounts of money to such bodies as do not keep any account?

SHRI G. MURAHAR1: They do not exist.

SHRI JAGANATH RAO: Grants are yiven to institutions which are legislered under the Societies' Registration Act. Therefore, every care is taken.

SHRI BHUPESH GUPTA: How do you know?

SHRI JAGANATH RAO: Before granting any grants the functioning of the institution is taken into consideration.

SHRIMAII JAHANARA JAIPAL SINGH: The Minister said that grants amounting to Rs. 200,00,000 were given direct to the institutions and not through the 'State Social Welfare Boards. Why are not utilisation certificates given to the Central Board? Why should they come to the State Boards?

SHRI JAGANATH RAO: It is according to convenience and to eliminate delay. On the recommendation of the State Social Welfare Board the Central Board sanctions the application and then gives the grant directly in most cases to avoid delay.

SHRIMAII TARA RAMCHANDRA SATHE: Is it not a fact that no grant is sanctioned unless somebody goes from the State Social Welfare Board and inspects that institution?

SHRI JAGANATH RAO: Yes, the Inspector of the State Social Welfare Board goes and inspects before making the recommendation.

SHRIMATI SHYAM KUMARI KHAN: Is it not a fact that unless there is a utilisation certificate every year and unless the audited accounts are received by the Central Social Welfare Board, no grants can be given again?

SHRI JAGANATH RAO: Yes that is correct.

Ministers attention been drawn to newspaper reports from time to time that grants are being made to non-existent institutions or for the purpose of patronage? If his attention has been drawn, how he proceeds in the matter especially when huge funds are being placed at the disposal of this body? May 1 know why the Government is not, in view of such allegations openly being made, seeing to it that the Ministry itself takes initiative in finding out from the authorities distributing the funds whether Ihey are doing it properly according to the purposes of the Social Welfare Board? It seems the Ministry is detached and non-aligned in this matter.

SHRI JAGANATH RAO: This Department of Social Security was formed only about eight months ago. In this period no complaint has been received by this Ministry. If the Member has any complaint in view, certainly I promise we will go into it.

(a) lo (d) The Co-ordination Committee of Rivers Steam Navigation Employees Unions addressed a Memorandum to the Union Minister of Transport on the 9th December 1964. A copy of the Memorandum is attached. [See Appendix LI, Annexure No. 3]. The Government of India have recently acquired a controlling interest in the equity capital of the Company and a new Board of Directors ha& been formed which will look into the points raised i.i the Memorandum (concerning the Company) including the proposal for retrenchment of surplus staff.

SHRI BHUPESH GUPTA: The statement says that the Government of India have recently acquired a controlling interest in the equity capital of the Company and a new Board of Directors has been formed which will look into the points raised in the Memorandum. May I have some idea about the controlling interest acquired by the Government? What is meant by controlling interest? What will be the position of the Government in the undertaking and what will be the position of the previous owners?

SHRI RAJ BAHADUR: After negotiations we have entered into an agreement which has been signed on 6th February 1965. under which all the 500,000 ordinary shares of £ 1 each of the River Steam Navigation Company Limited, have been taken over by the Government of India for a nominal value of \pounds . 1. For the time being 450,000 shares have been transferred in the name of the President
