### STRIKE AT CALCUTTA PORT

THE MINISTER OF TRANSPORT (SHRI RAJ BAHADUR): (a) to (c) Thirtythree Assistant Harbour Masters of the Port of Calcutta stopped working from the 12th January, 1965, the cause of grievance being the non-confirmation and non-continuance of Shri J. Prasad in the post of Harbour Masler-which was by a unanimous decision of the Calcutta Port Commissioners. There is no pending demand regarding any service, conditions as such before the Port Commissioners. They have not returned to duty so far.

The Mitsubishi Heavy Industries would complete the required surveys and present their reports by 30th April, 1966. \ fee of Rs. 15 lakhs is being paid to them for the purpose. Steps to construct the shipyard would be taken after the report of the Mitsubishi Heavy Industries is received by the Government.

# PURCHASE OF CARAVELLE PLANES FOR I.AC.

THE MINISTER OF TRANSPORT (SHRI RAJ BAHADUR): (a) and (b) No Central financial assistance has been provided lor the Calcutta Durgapur Express Highway so far. ft is essentially a State Scheme, and the Government of West Bengal are, therefore, primarily concerned in the matter. To begin with, the State Government have undertaken the constriction of the express highway in the first section from Calcutta to Palsit (near Burdwan) and the work is in preliminary stages of progress. Steps have been taken so far to acquire land in some stretches of the road and also to do some earth work and drainage crossings.
