

However, a copy of the memorandum seeking the support of Non-Aligned Nations Conference held in Cairo in October, 1964 was made available to the Government of India, and a copy of the same memorandum was handed over to all the Delegations, including Indian Delegation in Cairo.

(b) The question was not discussed at the Cairo Conference. The Government of India believe that these difficulties could best be resolved through direct negotiations between the parties concerned.

#### UNOFFICIAL COMMONWEALTH RELATIONS CONFERENCE

(b) The Commonwealth Relations Conference is generally held once in five years by rotation in different Commonwealth countries. The Conference in Delhi was held under the auspices of the Indian Council of World Affairs. Discussion on matters of mutual interest on various international events and their bearing on the Commonwealth take place in these Conferences;
