#### STUDY OF DUTIES OF L.D.C'S IN ORDNANCE CORPS

163. SHRI D. THENGARI : Will the Minister of DEFENCE be pleased to state :

(a) whether an on-the-spot study of the duties of Lower Division Clerks in the Ordnance Corps has recently been carried out by a Committee;

(b) if so, what were the terms of reference of that Committee and what are its findings;

(c) whether the recommendations made by this Committee have been implemented; and

(d) if the answer to part (c) above be in the negative, what are the reasons therefor?

THE MINISTER OF DEFENCE (SHRI Y. B. CHAVAN) : (a) to (d) The Army Standing Establishment Committee recently examined the question of proportion of Lower Division Clerks and Upper Division Clerks in Ordnance Depots and the Committee's recommendations are under consideration of the Government.

The strength of establishments, both Service and Civilian, in Army Units, etc., are determined on the basis of recommendations of the Army Standing Establishment Committee. All questions relating to changes in the cadre strength are decided by the Government on the basis of the recommendations of the Committee. The discussions of the Committee generally have bearing on the strength of individual arms/services and the work assigned to them, and as such, the deliberations of the Committee or the findings thereof cannot be divulged in public interest.

Government has, however, taken a decision to convert certain number of posts of Lower Division Clerks into those of Upper Division Clerks in the A.O.C. purely as an *ad hoc* measure, pending examination

of the general question affecting all Arms and Services.

#### U.D.C.'s IN ORDNANCE CORPS

(a) whether it is a fact that a large number of Upper Division Clerks in the Ordnance Corps are struck up at the maximum of their scale pay; and
