THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH): (a) and (b) No reply from the Government of Burma has been received. However, our Embassy in Burma has been pursuing the matter with the Burmese Foreign Office at Rangoon.

(c) The Government of Burma have constructed a Memorial Hall on the site, at the entrance of which a marble plaque mentioning that Lokmanaya Tilak was detained in the Mandalay Jail has been fixed. The memorial is well looked after and eared by the Mandalay jail authorities.
