TEACHING OF SOUTH INDIAN LANGUAGES ON RADIO

152. SHRI SITARAM JAIPURIA : Will the Minister of INFORMATION AND BROADCASTING be pleased to state :

(a) whether there is any proposal under Government's consideration for teaching South Indian languages to the Hindi-speaking people through medium of radio;

(b) if so, what are the details thereof; and

(c) when the proposal would be put into effect ?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI INDIRA GANDHI) : (a) to (c) For a number of years, various stations of All India Radio were broadcasting regular programmes designed to teach Hindi to non-Hindi speaking listeners, and in July, 1962 a series of programmes for the teaching of a non-Hindi language to Hindi listeners was also introduced from the Delhi Station of All India Radio. All these broadcasts had, however, to be suspended in December, 1962 in order to accommodate various types of programmes dealing with themes relating to the national emergency following the Chinese aggression. Broadcasts designed to teach various Indian languages 10 radio listeners will be resumed as soon as possible.

INDIANS IN BRITISH GUIANA

153. SHRI T. V. ANANDAN : Will the Minister of EXTERNAL AFFAIRS be pleased to state :

(a) whether Government's attention has been drawn to a news-item appearing in the 'Madras Mail' of the 31st December, 1964 to the effect that about two thousand Indians in British Guiana staged demonstrations demanding that they should be sent back to India unless British Guiana was partitioned into separate zones for Negroes and Indians; and

(b) if so, what is Government's reaction in the matter ?

THE MINISTER OF EXTERNAL AFFAIRS (SARDAR SWARAN SINGH) : (a) Government's attention has been drawn to the news-item referred to in the question. The Government of India's representative in Trinidad, however, reports that some references to partition of British Guiana have been made but none to the demand for repatriation in case partition was not effected.

(b) The Government of India do not consider partition as a desirable solution to the problems in British Guiana. Peoples of African and Indian origin in British Guiana have got to live together which will be in the best interests of that country and of both the groups.

PUBLICATION OF INDIAN COAL STATISTICS

154. SHRI P. K. KUMARAN : Will the Minister of LABOUR AND EMPLOYMENT be pleased to state :

(a) the reasons for the delay in the publication of Indian Coal Statistics, 1963;

(b) whether any steps are being taken to expedite the publication; and

(c) when it is likely to be published ?

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI D. SANJIVAYYA) : (a) The publication is compiled from the annual returns submitted by the collieries and it takes a little time to process, scrutinise and compile the data. The manuscript was sent to the Press on 7th October, 1964.

(b) Yes. The matter is being pursued with the press.

(c) Shortly.

EXAMINATION FOR THE SURVEYOR'S CERTIFICATE OF COMPETENCY

155. SHRI P. K. KUMARAN: Will the Minister of LABOUR AND EMPLOYMENT be pleased to state :

(a) whether the Government have examined the proposal of holding examination for the 'Surveyor's Certificate of Competency' under the Mines Act, 1952 simultaneously at Kothagudium and Dhanbad;

(b) if so, what are the details thereof; and

(c) if the reply to part (a) above be in the negative, what are the reason therefor ?

THE MINISTER OF LABOUR AND EMPLOYMENT (SHRI D. SANJIVAYYA) : (a) Yes.

(b) It has not been found feasible to have a separate Centre at Kothagudium.

The number of candidates from Kothagudium area is very small (only about 3 per cent) as compared to the total number of candidates appearing at the examination.
