CALCUTTA RADIO STATION

747. SHRI D. L. SEN GUPTA: Will the Minister of INFORMATION AND BROADCASTING to pleased to state:

(a) whether any artists are employed at the Radio Station at Calcutta on monthly pay basis;

(b) if so, the number of these artists with their scales of pay and other allowances; and

(c) what are the rates of payment made to other artists at the Radio Station at Calcutta who are engaged on contract basis?

THE MINISTER OF INFORMATION AND BROADCASTING (SHRIMATI INDIRA GANDHI): (a) Yes, Sir. Pending their appointment on a contract basis, some staff artists are engaged on a month-to-month basis, as a temporary arrangement.

(b) The number of such artists is 12. Out of these, one is getting a monthly fee of Rs. 120 and 11 a monthly fee of Rs. 200 each. No allowances are being paid to these artists.

(c) The other artists, employed as Staff Artists on contract, are paid fees according to the scales prescribed by the Government for the various categories of staff artists as shown in the attached Statement. [See Appendix LI, Annexure No. 34]. They are also entitled now to Allowances admissible to regular Government servants.
