

बार विचार किया है। पिछली बार 7 नवम्बर, 1963 को वित्त मन्त्रियों की दिल्ली में हुई बैठक में जब इस सुझाव पर विचार किया गया था तो सभी राज्य सरकारों के प्रतिनिधि इस योजना को और अधिक वस्तुओं पर लागू करने के पक्ष में नहीं थे और इसीसे इस सुझाव को छोड़ दिया गया था। चूंकि मंत्रिधन के अन्तर्गत बिक्री कर सामान्यतः कर निर्धारण का राज्य विषय है, इसलिए, जब तक सभी राज्य सरकारें इससे सहमत नहीं होती, केन्द्रीय सरकार इस सुझाव को अमल में नहीं ला सकती है।

†[THE MINISTER OF FINANCE (SHRI T. T. KRISHNAMACHARI): The suggestion to replace sales-tax by excise duty has been considered by the Central Government time and again. On the last occasion when this suggestion was discussed at the Conference of Finance Ministers held in New Delhi on the 7th November, 1963, representatives of all the State Governments were opposed to the extension of this scheme to any more commodities and the suggestion was, therefore, dropped. Since sales tax is generally a State subject of taxation under the Constitution, the Central Government cannot implement the suggestion, unless all the State Governments agree to it.]
