

## STATEMENT

(a) and (b) The acquisition of ships from Yugoslavia is a continuous process and goes on from Plan to Plan. So far, Government have permitted the Shipping Corporation of India Ltd., a public sector concern, to place orders for the construction of 4 coastal ships and 3 bulk carriers in Yugoslavia at a total cost of Rs. 5.25 crores and 7.10 crores respectively on credit terms. The orders for the building of coastal vessels were placed by the Corporation on 29th January, 1964 and that of the bulk carriers on 12th February, 1965. Besides these orders placed by the Public Sector Company, Messrs. Chowgule Steamships Limited, Goa have already taken delivery of three new cargo-cum-passenger vessels on 25th December, 1964, 8th May, 1965 and 9th September, 1965, at a total cost of Rs. 1.95 crores under Yugoslav credit. Certain fresh proposals for the acquisition of ships from Yugoslavia are being received from Indian shipping companies and they are under consideration of Government at present.

THE MINISTER OF FOOD AND AGRICULTURE (SHRI C. SUBRAMANIAM): (a) and (b) It is proposed to entrust the direct purchase operations of rice to the Food Corporation by stages. During the next Kharif season the Corporation will undertake these purchases partly in the States of Andhra Pradesh, Madras, Mysore, Kerala and the Union territory of Pondicherry and Karaiikal.
