Kerala Government have undertaken a programme of protection of vulnerable reaches of the coastline and this work is being continued in the current year. AD outlay of Rs. 60 lakhs has been approved for this purpose during the current year. A total length of 3 miles of seawall is expected to be completed during the year.

In their preliminary Memorandum for the Fourth Plan, the Kerala Government have suggested a provision of Rs. 30 crcret for protection of 120 miles of sea coast.

Maharashtra:

The Government of Maharashtra have sanctioned Rs. 14-51 lakhs for permanent protective measures at Rajiwada RatnagirJ and the work is in progress.

The State Government have proposed Rs. 50 lakhs in the draft Fourth Plan for antisea erosion measures, the details of which have not yet been worked out.

CALLING ATTENTION TO A MATTER OF URGENT PUBLIC IMPORTANCE

SERIOUS POWER SHORTAGE IN THE STATE OF MADRAS AND ITS ADVERSE EFFECT ON PRODUCTION

SHRI T. S. PATTABIRAMAN (Madras): Sir, I beg to call the attention of the Minister of Irrigation and Power to the serious power shortage in the State of Madras and its adverse effect on the industrial and agricultural production in that State

THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO): Power supply in Madras State is at present both from hydro and thermal stations, the total installed capacity at present being a little over 1,100 MW, comprising 400 MW from thermal installations at Madurai, Madras and Neyveli and 720 MW of hydro power plant at Papanasam, Periyar, Mettur, Pykara, Moyar and Kundah.

The failure of the South West Monsoons resulted in poor storage in the Hydel Reservoirs in Madras State. Consequently there
