## RURAL UNEMPLOYMENT

\*714. SHRI D. THENGARI: Will the Minister of PLANNING be pleased to state the measures proposed by Government to reduce rural unemployment and underemployment during the Fourth Five Year Plan?

THE MINISTER OF PLANNING (SHRI B. R. BHAGAT): Besides various programmes for agricultural and industrial development and development of economic and social overheads, the Fourth Plan will provide for a sizeable rural manpower programme. Details of this programme have not yet been finalised.

- (a) whether it is proposed to shift the Nehru Museum from its present site in Teen Murti to a new building in Shantivana;

Will the PRIME MINISTER be pleased to state:

- (a) whether any Indian industrialists have donated money to the Pakistan Defence Fund:
- (b) if so, what are their names and what are the amounts donated by them; and

(c) what are the amounts donated by these industrialists to our National Defence Fund?

THE MINISTER OF PLANNING (SHRIB, R. BHAGAT): (a) to (c) Government have seen these reports but they have no definite information. No Indian businessman has any control over enterprises that he owns in Pakistan since the beginning of hostilities. These have been taken over by the Pakistan Government as enemy property. As such, the assets of Indian business enterprises in Pakistan are at the disposal of the Government of Pakistan for them to do what they wish. It is possible that these assets are being used for the purpose indicated.

## PER CAPITA CONSUMPTION

493. SHRI JAIRAMDAS DAULAT-RAM: Will the Minister of FINANCE be pleased to state what was the *per capita* consumption in India in rupee value of all goods taken as a whole in the last years of the First and the Second Five Year Plans and the final year of the Third Five Year Plan?

THE MINISTER OF FINANCE (SHRI T. T. KRISHNAMACHARI): There is no official statistical series of per capita consumption. On the basis of the Reserve Bank's estimates of house hold savings, per capita consumption can be derived from the national income estimates, and this works out to Rs. 230 in 1955-56 and Rs. 296 in 1960-61. It is not possible to estimate at this stage the level of per capita consumption in 1965-66.

- (a) the amount of Indian capital sanctioned for investment in foreign countries during the last four years;
