The Medical Council of India has inspected several of these colleges. With the exception of Christian Medical College, Vellore, Ludhiana and Bangalore, most of the other private medical colleges are reported to have inadequate facilities in regard to clinical beds and staff. The Christian Medical College at Ludhiana and Bangalore and the Calcutta National Medical Institute are reported to have fair arrangements but not fully in keeping with the Council's requirements.

Except for private medical colleges at Vellore, Ludhiana, Punjab and St. John's Medical College, Bangalore, capitation fees for admission are charged by all the rest. The Alleppey medical college (Kerala) has also stopped charging capitation fees since July, 1965 under orders of the Kerala Government.

PURCHASE OF GAS TURBINES

500. SHRI D. THENGARI: Will the Minister of IRRIGATION AND POWER be pleased to state:

THE DEPUTY MINISTER IN THE MINISTRY OF IRRIGATION AND

POWER (SHRI S. D. MISRA): (a) and (b) It has been agreed to provide a sum of Rs. 50 lakhs as additional Central assistance to the Government of Rajasthan to meet the expenditure on the installation of a 10 MW gas turbine set at Kota on transfer from Mysore.

FOREIGN EXCHANGE FOR MEDICAL STUDENTS

- 501. SHRI RAM SINGH: Will the Minister of FINANCE be pleased to state:
- (a) whether it is a fact that Government have decided to issue foreign exchange only to those medical students who undertake to serve the country for a stipulated period after their studies abroad:
- (b) whether any such conditions have been imposed on students seeking foreign exchange for other branches of technical education; and
- (c) if the answer to part (b) above be in the negative, the reasons for this differentiation?
