NATIONAL DEFENCE GOLD BONDS, 1980

A new series of Gold Bonds 1980, subscriptions to which opened on the 27th October, 1965, will be on sale upto 31st January, 1966. The salient features of the scheme are:

- (1) Subscriptions for the Bonds will be accepted only in the form of gold, gold coins and gold ornaments.
- (2) The Bonds will be repaid in gold of .995 fineness on 27th October, 1980. During the period between the sale of the Bonds and their repayment, the Bond holder will be entitled to Rs. 2 per annum for every 10 grammes of gold of the above fineness.

Gold subscribed to Gold Bonds in the form of ornaments of more than 14 carat purity can on repayment in 1980 be reconverted into ornaments of any purity.

- (3) In the case of ornaments, a premium of Rs, 3 for every 10 grammes of gold of .995 fineness will also be allowed with a view to compensating subscribers for charges incurred while making the ornaments. The amount will be paid at the time of issue of the Bonds.
- (4) No income-tax will be payable on the premium and annual payments. No capital gains tax will be levied on the gains from the sale on transfer of these Bonds. Capital loss, if any, will not be eligible for being set off. Gift tax will not be charged on the gifts in a year made by the initial subscriber upto the value of Bonds for five kilogrammes of gold. Estate duty will not be levied on the first occasion when Bonds pass on the death of a holder upto the value of Bonds for 50 kilogrammes of gold.
- (5) The provisions of Gold Control or Customs Regulations will not apply to gold tendered as subscription to the Gold Bonds; no proceedings will be instituted or any penalty levied

under these regulations in respect of such gold.

Where gold tendered for these Bonds has been acquired out of the undisclosed income such income the wealth represented by the corresponding assets will not be liable to tax in assessments made after 19th October, 1965, if such has not been assessed to tax on or before the 19th October, 1965 and it had not been detected by the Incometax Officer before the gold was tendered for these Bonds. The exemptions will not be available in case where the gold tendered subscription had beenpreviously seized under any law before the date of subscription.

The identity of the persons subscribing to the Bonds or the particulars of the Bonds will be treated as confidential, not even the courts may require any public servants to give evidence in the matter.

(6) The Bonds are negotiable.

POWER CUT IN MADRAS AND KERALA

- (a) whether Madras and Kerala are facing electricity power cut; and
- (b) if so, the steps taken to meet the crisis?

THE MINISTER OF IRRIGATION AND POWER (DR. K. L. RAO): (a) Yes, Sir.

- (b) Government of Mysore have agreed to supply 400 million kWh and 80 million kWh to Madras and Kerala respectively upto end of June, 1966. Efforts are also being made to commission power projects aggregating to 185 MW and 118 MW in Madras and Kerala respectively by the end of March, 1966.
