[THE DEPUTY MINISTER IN THE

RAMASWAMY) : (a) Lower export in 1963-64
was due to lower production in India resulting
from adverse weather conditions during the
two consecutive years viz., 1962 and; 1963
which reduced the availability of tea. Also the
10-12 day closure of tea, auctions and exports
of tea during January, 1964 due to civil
disturbances lost us about Rs. 10 to 12 crores
worth of tea exports.

(b) A dynamic and vigorous campaign of
foreign promotion is being successfully
implemented by the Tea Board to increase
tea exports and to create new markets.
Intensive promotion to project the image of
Indian tea is proposed to be carried out in
both traditional and non-traditional markets.]

relations of a Central Minister, who are not
dependent on him, have a minority interest in
a company that is going to Produce
contraceptives. The products manufactured by
the company, it is understood, are being
placed on the list of approved contraceptives.

CALLING ATTENTION TO A MATTER OF URGENT PUBLIC IMPORTANCE

REPORTED ARREST OF SEVEN PERSONS IN DELHI UNDER THE OFFICIAL SECRETS ACT, 1923

SHRI M. P. BHARGAVA (Uttar Pradesh):
May I call the attention of the Minister of
Home Affairs to the reported arrest of seven
persons in Delhi under the Official Secrets
Act, 1923, alleged to be the members of a spy
ring operating in the country?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI JAISUKHLAL HATHI): Sir, I can understand the anxiety of Members over what has been reported in the papers as the operation of a spy ring in the country. All that I can say at the present stage of investigation is that seven persons have been arrested under section 3 of the Official Secrets Act as there were reasonable grounds to believe that they had passed on information bearing on secret matters to an officer of a diplomatic mission in Delhi. All the available clues and material are being closely examined with a view to ascertaining the full ramifications of this case. It is necessary in the public interest including proper investigation of the case that no further information should be made public at this stage. I would, therefore, appeal to the hon. Members not to press me to disclose more details.

This is a serious and delicate case and I do not wish to underestimate its implications. At the same time I would like the House to take the fact of its detection as evidence of the continuous and painstaking vigilance being exercised over matters relating to national security. I can give an assurance that this vigilance will continue to be exercised. Apart from vigorous investigation in progress, appropriate diplomatic action has also been taken.

SHRI M. P. BHARGAVA: Sir, while agreeing with the anxiety of the hon. Minister not to press this point any further, and congratulating the C.B.I. on the good work done in the detection of this spy ring, I would like to seek certain clarifications. The first clarification I seek is whether all the members of the spy ring have been arrested, or any further arrests are expected. The second point is that the Government will take full precautions . . .

SHRI A. B. VAJPAYEE (Uttar Pradesh): May I submit that questions may not be put.

MR. CHAIRMAN: Mr. Bhargava, I think, in view of the statement made by the Minister, that it is in the fitness of things not to press this matter any further.

SHRI M. P. BHARGAVA: Sir, I only want certain assurances on some very basic issues. The second point is that the Government will take all necessary action if any Government servants and V.I.Ps. are involved in this spy ring.

SHRI JAISUKHLAL HATHI: I am thankful to Shri Vajpayee for requesting the sponsor of this question not to put further questions. Investigation is going on. If it is necessary to arrest or take action against anybody else, whosoever he may be, it will be done".

SHRI A. B. VAJPAYEE: Sir, I do not want to seek any clarification. I am sure that Government will keep in mind the case of Colonel Bhattacharya when they will deal with these spies and, if necessary, a special court will be constituted to try them.
