- (a) whether he agreed to give substantial financial aid to the Government of Punjab from out of the National Calamities Fund for helping the schools which have been adversely affected by the recent floods in Punjab; and
- (b) if so, what amount has so far been given for the purpose?

THI MINISTER oy FINANCE (SHRI T. T. KRISHNAMACHARI): (a) There is no fund in the Government of India, known, as National Calamities Fund. However, on a request from the Punjab State Government, it ha9 been agreed to consider the question of providing financial assistance in the form of loans for repairs to schools buildings damaged by floods, if the expenditure on relief operations substantially exceeds the limit of Rs. 80 lakhs upto which the State Government are expected to finance the expenditure from their own resources.

(b) No amount has so far been given.
