FIRING BY PAKISTANI FORCES ON INDIAN BORDER

336. THAKUR BHANU PRATAP SINGH; Will the Minister of DEFENCE be pleased to state:

(a) the number of times Pakistan armed forces resorted to firing on Indian border villages during the last two months; and

(b) the number of persons injured/ killed due to these firings?

THE MINISTER OF DEFENCE (SHRI, Y. B. CHAVAN): (a) There were 287 firing incidents on the cease-fire line and border in Jammu and Kashmir during the period of two months from 20th September 1964. On Assam and West Bengal borders, there was one firing incident each during this period. On the Tripura border, there was firing near Belonia town twice, Anandpur village once and intermittent firing since 17th November on Karangicherra village.

(b) During the above-mentioned period, in Jammu and Kashmir, 33 Indians were killed and 39 wounded. On the Pakistan side, 66 persons are believed to have been killed and 26 wounded, in Tripura one Indian was killed, while in Assam and West Bengal one Indian each was wounded. No casualties were reported on the Pakistan side.
