(b) if so, what is Government's reaction in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI N. MENON): (a) Yes, Sir.

(b) As the northern areas of the Indian State of Jammu and Kashmir are under Pakistan's unlawful occupation and as the Security Council is seized of the matter, the Government of India have taken no further steps in the matter.

THE PRIME MINISTER AND MINISTER OF ATOMIC ENERGY (SHRI LAL BAHADUR): (a) The total investment on the new plant at Manavalakurichi is likely to be of the order of Rs. 35 lakhs.

(b) The new plant will produce ilmenite, monazite, rutile and zircon.
