INVESTIGATIONS INTO JAY ENGINEERING COMPANY

*333. **SHRI P. ABRAHAM:** Will the Minister of FINANCE be pleased to refer to the reply given to starred Question No. 367 in the Rajya Sabha on the 23rd September, 1964 and state:

(a) whether the investigations into M/s. Jay Engineering Company Ltd., have since been completed;

(b) if so, what are the charges against the firm; and

(c) what action has been taken against the Directors and the Chairman of the Company?

THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRI RAMESHWAR SAHU): (a) and (b) One case has been adjudicated. Some other cases are under adjudication and further investigations are also in progress.

†SCISSORS FOUND IN STOMACH

*262. **SHRI JAGAT NARAIN:** Will the Minister of HEALTH be pleased to state:

(a) whether Government's attention was drawn to an allegation that a pair of scissors was found in the stomach of a girl who had been recently operated in one of the Government hospitals;

(b) if so, whether any enquiry was conducted by the Delhi Administration in this regard; and

THE MINISTER FOR HEALTH (DR. SUSHILA NAYAR): (a) and (b) Yes, Madam.

(c) The enquiry has brought out that a broken dressing scissors was removed from inside the stomach of Kumari Mirdula Agarwal. The medical opinion is unanimous that the scissors were not and could not possibly be left inside the stomach during the operation for appendicitis done on 14-6-64 at the Irwin Hospital. The medical opinion also specifically suggested that the scissors could reach the stomach only after swallowing them by the mouth. The scissors were broken in two parts and this breaking could not, under any circumstances occur within the stomach itself.
