PRODUCTION OF ELECTRIC LOCOMOTIVES IN THE FOURTH FIVE YEAR PLAN

395. SHRI U. S. DUGAL: Will the Minister of RAILWAYS be pleased to state:

(a) whether it has been decided to increase the production of Electric locomotives in the Fourth Five Year Plan; and

(b) if so, how much amount has been sanctioned for the same?

THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAM SUBHAG SINGH): (a) Yes; it has been decided to increase the capacity for the production of electric locomotives, at the Chittaranjan Locomotive Works, during the Fourth Five Year Plan.

(b) An amount of Rs. 1- 73 crores has recently been sanctioned for this purpose, of which Rs. 1.05 crores are for the provision of facilities for the manufacture of traction motors required for electric locomotives.
