

## STATEMENT

No foreign exchange has been sanctioned to M/s. Bird & Co. as such for the purpose mentioned in the question. Perhaps the Hon'ble Member has M/s. Titaghur Paper Mills in his mind. If so, the position is that import licences worth about Rs. 77 lakhs were issued to that company during the period 1953 to 1959. These licences are reported to have been fully utilised and no license in full or in part appears to have been surrendered.

## DISMISSAL OF A DEPUTY DIRECTOR GENERAL IN DEPARTMENT OF SUPPLY AND DISPOSALS

\*366. SHRI P. ABRAHAM: Will the Minister of INDUSTRY AND SUPPLY be pleased to state:

(a) whether it is a fact that a Deputy Director General of the Directorate General of Supplies and Disposals was dismissed from service recently on charges of corruption; and

(b) if so, whether Government propose to prosecute him under the Prevention of Corruption Act and if not, the reasons therefor?

THE MINISTER OF SUPPLY AND TECHNICAL DEVELOPMENT IN THE MINISTRY OF INDUSTRY AND SUPPLY (SHRI K. RAGHU RAMAIAH):

(a) Yes, Sir.

(b) The matter is still under consideration.

## PURCHASE OF WOOL AGAINST RUPEE PAYMENT

\*367. SHRI SANKAR PRATAP SINGH DEV: Will the Minister of COMMERCE be pleased to state:

(a) whether Government have decided to buy 5 million lbs. of wool against rupee payment; and

(b) if so, the manner in which the wool will be utilised?

THE DEPUTY MINISTER IN THE MINISTER OF COMMERCE (SHRI S. V. RAMASWAMY): (a) and (b) The International wool Secretariat in its Report on the "Economics of Modernisation in the Indian Wool Textile Industry" *inter alia* recommended the establishment of a strategic reserve, or stock-pile of imported raw materials on which manufacturers can draw against export orders with the minimum delay and formality. Government have accepted this recommendation and are examining the possibility of importing about 5 million lbs of wool from Australia for building up an effective stock-pile along with the modernisation scheme.

## PULP MANUFACTURING PLANT

\*368. THAKUR BHANU PRATAP SINGH: Will the Minister of INDUSTRY AND SUPPLY be pleased to state:

(a) whether a proposal is under Government's consideration regarding the setting up of a pulp manufacturing plant in the public sector in the Fourth Five Year Plan period;

(b) if so, where the proposed plant will be set up?

THE MINISTER OF HEAVY ENGINEERING AND INDUSTRY IN THE MINISTRY OF INDUSTRY AND SUPPLY (SHRI T. N. SINGH): (a) and (b) Yes, Sir. All relevant data on the subject is being collected by the National Industrial Development Corporation and as soon as the necessary data is made available, decision on the establishment and location of the plant will be taken.

## HOUSE RENT ALLOWANCE FOR EMPLOYEES OF H.E.C.

\*369. SHRI P. C. MITRA: Will the Minister of INDUSTRY AND SUPPLY be pleased to refer to para 3 of the answer given to Starred Question No. 389 in the Rajya Sabha on the 24th September, 1964, in which it was stated that a decision in regard to the res-

toration of house rent allowance to the employees of the Heavy Engineering Corporation, Ranchi, was 'likely to be taken in the next few days' and state whether that decision has since been taken and if so, what is that decision?

**THE MINISTER OF ENGINEERING AND INDUSTRY IN THE MINISTRY OF INDUSTRY AND SUPPLY (SHRI T. N. SINGH):** Yes, Sir. House rent allowance has been restored retrospectively with effect from the 1st January, 1963, the date from which it was discontinued.

**THE MINISTER OF STATE IN THE MINISTRY OF RAILWAYS (SHRI RAM SUBHAG SINGH):** (a) and (b) A copy of the report on "Transport Requirements of the Iron and Steel Belt" published by the National Council of Applied Economic Research has been received. No suggestions have been addressed specifically by the National
