- (b) what are the various steps Government have taken for better external publicity by the Indian missions abroad; and
- (c) how many Indian missions abroad have so far been visited by the Special Reorganisation Unit of the Ministry of External Affairs?

THE MINISTER OP STATE IN THE MINISTRY OF EXTERNAL AFFAIRS (SHRIMATI LAKSHMI N. MENON): (a) to (c) A statement is placed on the Table of th<sub>e</sub> House.

## STATEMENT

The following are some of the measures taken to curtail the expenditure in Indian Missions abroad: — (i) Cut in expenditure on various services.

- (ii) Restrictions on cost of passa ges, periodical transfers and local tours of officers and staff.
- (iii) Cut in Representational Grants.
- ,(iv) Review of existing posts by high powered bodies.
- (v) Restrictions on opening of new Missions to the barest minimum.
- ,(vi) Efforts to substitute locally recruited staff in lieu of India-based staff, provided no security risk is involved.

Indian Missions abroad produce and distribute pamphlets on India; show documentaries and feature films; maintain libraries; supply information sought; organise cultural and social functions; and send out speakers to lecture on India. In addition, 41 of these Missions also bring out journals in respective local languages.

There is no such body as Special Reorganisation Unit in the Ministry of External Affairs. There is, however, a Special Reorganisation Committee, which reviews the staff position in Indian Missions from time to time. The Committee does not visit the Missions.
