NON-SUPPLY OF BUFFALO AND COW MILK BY DELHI MILK SCHEME

\*559 SHRI RAM SINGH Will the Minister of Food and Agriculture be pleased to state:

(a) whether it is a fact that during October 1964, no buffalo or cow milk was supplied to the card holders by the Delhi Milk Scheme; and

(b) if so, the reasons therefor?

THE MINISTER OF FOOD AND AGRICULTURE (SHRI C SUBRAMA-NIAM) (a) and (b) A statement is placed on the table of the Sabha.

#### STATEMENT

(a) Delhi Milk Scheme was unable to meet its commitments for supply of buffalo milk for some days during October, 1964 and toned milk in lieu of buffalo milk was supplied upto 20th October 1964 Supply of toned milk had also to be reduced by about 50 per cent. from 27th September 1964 to 12th October 1964.

Cow milk was supplied to the card holders throughout the month of October, 1964 except on 7th, 23rd and 27th October, 1964 On 24th, 26th, 28th, and 31st October, 1964, a partial supply of cow milk was made.

- (b) There has been a shortfall in the quantity of buffalo milk cured by the Delhi Milk Scheme for the following reasons:
  - (i) There was some agitation among milk suppliers because of procurement of milk by the scheme through Cooperative Societies at the Milk Collection and Chilling Centre at Kithore. Uttar desh.
  - (11) The greatly increased price in the Delhi Market of products like cream and ghee which makes it profitable for supplier to divert milk for the manufacture of cream and ghee.
  - (111) Unhealthy competition by private purchasers particu-

larly in regard to price and quality of milk purchased from the suppliers.

- (iv) Increased demand due to 'Shradhas' and festivals, etc.
- (v) Effect of heavy rain and floods on fodder crop, which has affected the production of milk.

## COMPLAINTS AGAINST USE OF OFFICIAL MACHINERY IN PHULPUR BYE-ELECTION

'561. SHRI R. S. KHANDEKAR: Will the Minister of Law be pleased to state:

- (a) whether it 18 a fact that the Chief Election Commissioner has received various complaints regarding the use of official machinery in the Phulpur bye-election to the Lok Sabha; and
- (b) if so, what steps were taken to prevent the misuse of power'

The MINISTER of LAW (Shri A. K. Sen): (a) The Election Commission received complaints from the Sanyukta Socialist Party that a large number of jeeps and Government servants were utilised by the Congress candidate at the Phulpur bye-election; but both the State Government and the Returning Officer reported that no Government vehicles or officers were utilised by the Congress party candidate. No specific complaint was lodged with the Returning Officer to this effect.
