THE DEPUTY MINISTER IN THE DEPARTMENT OF COMMUNICATIONS (SHRI B. BHAGAVATI): A proposal for upgrading Dhenkanajl Sub Post Office in Orissa into a Heaji Post Office is already under active consideration and this office is likely to be upgraded in the course of the next few months.

POST OFFICE AT NAGERCOIL

64. SHRI P. THANULINGAM: Will the Minister of COMMUNICATIONS be pleased to state when the original post office at Nagercoil, District Konnia Kumari was demolished; and what are the reasons for the delay in the construction of the new building?

THE DEPUTY MINISTER IN THE DEPARTMENT OF COMMUNICATIONS (SHRI B. BHAGAVATI) : The old Post Office building at Nagercoil was demolished on the 22nd December, 1962.

The work could not be started a* due to declaration of the emergency in October, 1962, there was curtailment in building activity. Priority for the work was accorded only in October, 1963, and thereafter Working drawings for the work were prepared. Further, due to limited capacity of thr Civil Engineering Wing, detailed est-mate for the work could not be finalised, as the staff were engaged works of higher priority.

Steps have been taken to sanction additional staff. Estimate for the work is now under preparation and the work will be taken un after approval.
