TLTHE MINISTER OP FINANCE (Simr T. T. KRISHNAMACHARI): (a) The General Financial Rules, Delegation of Financial Power Rides, Study Leave Rules and Staff Car Rules have since been simplified, codified and issued. The work in respect of other rules, viz., Pay Code, Travelling Allowances Code, Pension Code, Leave Code and House Rent and Compensatory (City) Allowances Rules is in progress. The revision of Treasury Rules is also in progress.

(b) Yes, Sir. The Rules which have been simplified are being translated into Hindi. The other remaining Rules will also be translated into Hindi when they are finalised.!
