THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI JAISUKHLAL HATHI): (a) Broadly, Governments' measures to give relief to persons affected by communal riots earlier this year in the State of West Bengal, Bihar, Orissa Madhya Pradesh, place special emphasis on the speedy restoration of their sense of security and confidence so that the displaced persons could return to their homes. Rehabilitation benefits are extended in the form of grants or loans for construction of dwellings and for purchase of means of cultivation which might have been destroyed, and for starting trades and
